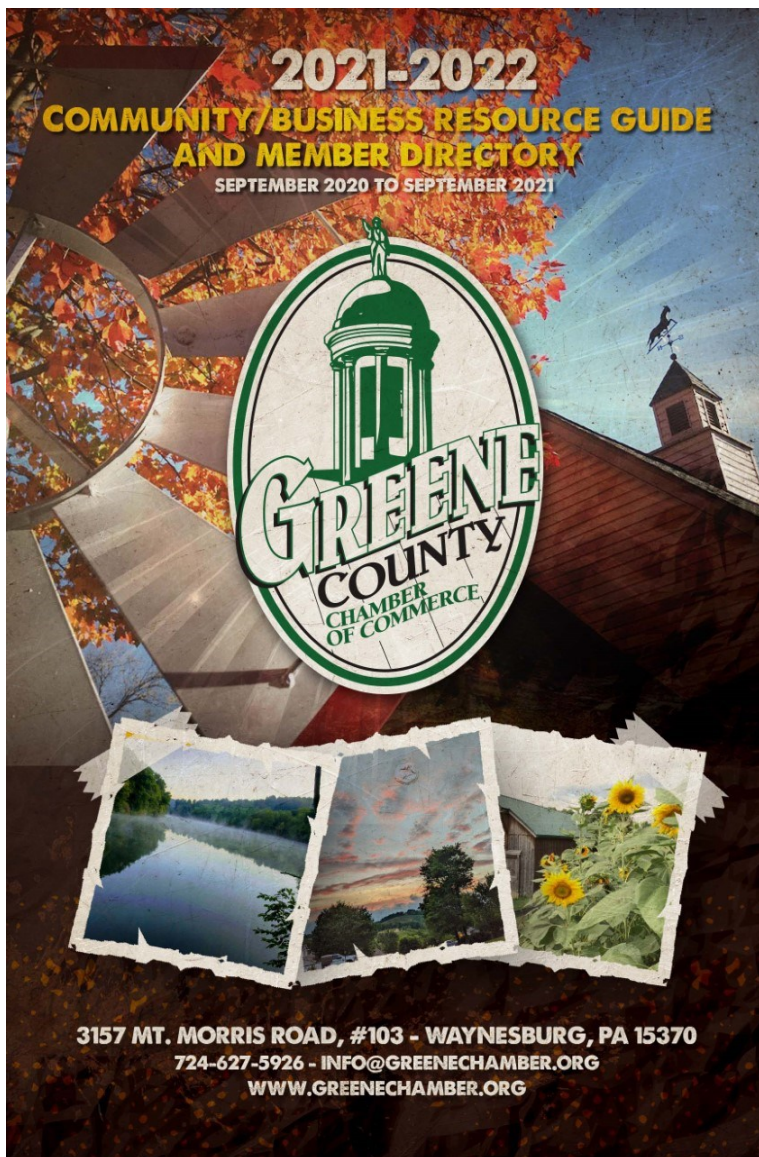

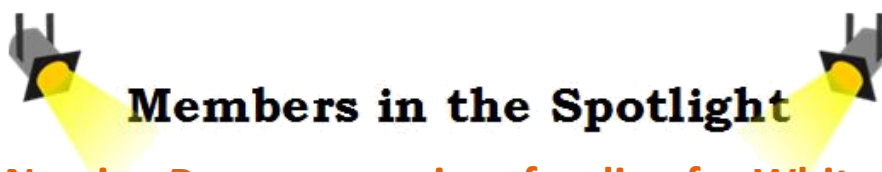

Nursing Program receives funding for White Coat Ceremony



The Waynesburg University Nursing Program was recently a recipient of grant funding from the Arnold P. Gold Foundation to initiate its inaugural White Coat Ceremony. The ceremony was held Saturday, Oct. 23, in Roberts Chapel on the University's main campus.

"Since 1993, the White Coat Ceremony has been an early and essential touchpoint of humanism on the path of a physician," said Dr. Richard I. Levin, president and CEO of the Gold Foundation. "Today... the White Coat Ceremony is all the more relevant in emphasizing the importance of the human connection in healthcare. We are grateful for the leadership of Waynesburg University in elevating the message, both during the ceremony and throughout the years of education, that empathy and respect are critical parts of optimal care."

The White Coat Ceremony is a rite of passage to emphasize the importance of compassionate patient care at the very start of the educational program.

Waynesburg's event included remarks by Waynesburg University President Douglas G. Lee and Dr. Kathy A. Stolfer, director and chair of the Department of Nursing. A virtual keynote address was presented by Dr. Deborah Trautman, PhD, RN, FAAN, president and CEO of the American Association of Colleges and Nursing (AACN). Dr. Trautman was introduced by Dr. Lorraine Frazier, PhD, RN, FAAN, FAHA, dean of the Columbia University School of Nursing and a Gold Foundation trustee, and Dr. Kellie Bryant, DNP, WHNP, CHSE, assistant dean of Clinical Affairs and Simulation Center at the Columbia University School of Nursing. Also in attendance were faculty members of the Department of Nursing, who pinned students as they came forward in their newly donned white coats.

The White Coat Ceremony was initiated in 1993 at Columbia University Vagelos College of Physicians & Surgeons by Dr. Arnold P. Gold, MD, a professor and pediatric neurologist.

According to the Gold Foundation, Dr. Gold was a passionate advocate for humanistic healthcare. He and his wife, Dr. Sandra Gold, started The Arnold P. Gold Foundation, which has expanded the White Coat Ceremony internationally. The application process is managed by the American Association of Colleges of Nursing (AACN).

Today, nearly every medical school in the United States, hundreds of nursing schools and many other health profession schools around the world participate in this tradition.

Greene County Forgivable Advance for Small Business Assistance

(FASBA)

*Eligibility Requirements Apply



The Purpose:

The Forgivable Advance for Small Business Assistance (FASBA) provides up to \$50,000 grants for small, local businesses who have been impacted by the COVID-19 pandemic. These are federal grants to fund local programs to relieve businesses of the economic disaster and keep the county thriving.

This is not a first-come, first serve program.

To be eligible, a business must:

- Demonstrate it experienced a 25% annual or quarterly disruption due to the COVID-19 crisis
- Provide evidence of viability before crisis
- Document at least one Full Time Equivalent (FTE) job created or retained where the employee meets the definition of low to moderate income OR business and job located in 20% poverty and general distress 30% poverty, central business district and general stress
- Businesses that earn \$1 Million or less in revenue are eligible
- Have at least 1-year business operations and at least 1-year tax returns
- Evidence up-to-date on taxes or have a payment plan
- Business has 100 or fewer employees worldwide

Ineligible Businesses:

- Non-profits
- Real Estate Developers
- Businesses providing assistance in the form of lobbying or other political activities
- "Sin" businesses, as defined by HUD

Funds can be used for:

- Payroll
- Rent/Mortgage
- Utilities (gas, phone, etc.)
- Supplies (up to 90 days)
- Inventory (up to 180 days)
- Insurance
- Accounting
- Legal
- Advertising

Businesses can prove compliance and the advance can be forgiven in 120 days!

SBA Offers Disaster Assistance to Greene County Businesses and Residents Affected by July Flooding

Greene County businesses and residents affected by the flooding on July 29th, 2021, may apply for low-interest disaster loans from the U.S. Small Business Administration, SBA Administrator Isabella Casillas Guzman announced today.

Administrator Guzman made the loans available in response to a letter from West Virginia Gov. Jim Justice on September 22nd, 2021, requesting a disaster declaration by the SBA. Businesses and residents in the declared areas can now apply for low-interest disaster loans from the SBA.

The declaration includes Monongalia County and the adjacent counties of Marion, Preston, Taylor, and Wetzle in West Virginia; and Fayette and Greene in Pennsylvania.

“SBA’s mission-driven team stands ready to help small businesses and residents impacted by the flooding,” said Administrator Guzman. “We’re committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help businesses and communities recover and rebuild.”

“Businesses and private nonprofit organizations may borrow up to \$2 million to repair or replace disaster-damaged or destroyed real estate, machinery and equipment, inventory, and other business assets,” said SBA’s West Virginia District Director Karen Friel.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations, the SBA offers [Economic Injury Disaster Loans \(EIDL\)](#) to help meet working capital needs caused by the disaster. EIDL Loan assistance is available regardless of whether the business suffered any physical property damage.

“Loans up to \$200,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for loans up to \$40,000 to repair or replace damaged or destroyed personal property,” said Kem Fleming, director of SBA’s Field Operations Center East in Atlanta.

Applicants may be eligible for a loan amount increase up to 20 percent of their physical damages, as verified by the SBA for mitigation purposes. Eligible mitigation improvements may include a safe room or storm shelter, sump pump, French drain, or retaining wall to help protect property and occupants from future damage caused by a similar disaster.

Interest rates are as low as **2.855** percent for businesses, **2** percent for nonprofit organizations, and **1.563** percent for homeowners and renters, with terms up to 30 years. Loan amounts and terms are set by the SBA and are based on each applicant’s financial condition.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA’s secure website at [DisasterLoanAssistance.sba.gov/ela/s](https://disasterloanassistance.sba.gov/ela/s) and should apply under SBA declaration # 17198, not for the COVID-19 incident.

Disaster loan information and application forms may also be obtained by calling the SBA’s Customer Service Center at **800-659-2955** (800-877-8339 for the deaf and hard-of-hearing) or emailing DisasterCustomerService@sba.gov. Loan applications may be downloaded at sba.gov/disaster. Completed applications should be returned to the center or mailed to: U.S. Small Business Administration, Processing and Disbursement Center, 14925 Kingsport Road, Fort Worth, TX 76155.

The filing deadline to return applications for physical property damage is **Nov. 29, 2021**. The deadline to return economic injury applications is **June 29, 2022**.

Blood Facts & Statistics






- Every 2 seconds someone in the U.S. needs blood.
- One in 7 people entering a hospital will need blood.
- A single blood donation can help more than one patient and could help as many as three.
- Vitalant needs 5,300 donations every day to support patient needs in the 900 hospitals we serve.
- Vitalant needs over 216,000 new donors annually to safeguard blood needs for patients.
- The majority of the population is estimated to be eligible to donate blood but only 3% do.
- First-time donors get an initial screening of their blood type when they make their first blood donation at a Vitalant blood drive or donation center (not applicable in Nevada due to state restrictions).
- All blood types are critically needed, especially Type O.
- Type O is often needed in an emergency as well as for routine lifesaving surgeries, cancer treatment and more.
- Blood donation is an essential activity.
- All Vitalant blood drives and donation centers follow strict protocols to ensure the safety of donors, volunteers, patients and staff. Review current COVID safety measures at vitalant.org/COVID-FAQs.
- Blood donations decline as much as 20% during the winter months due to cold and flu and weather impacts.
- January is National Blood Donor month, a time to bring awareness to the constant need for new blood donors.

There is a critical blood and platelet shortage. The pandemic has impacted the number of people giving. In fact, about 92,000 fewer donors have visited Vitalant blood drives over the past year than the previous year. **About 1,000 more new and existing donors are needed each week to replenish the blood supply.**

Campaign Guidelines




- Host an on-site and/or virtual blood drive in November, December and/or January to qualify.
- Complete your on-site and/or virtual blood drive with at least 20% of the total donations from first-time donors and be automatically entered to win one of 5 \$300 Amazon.com gift cards in three monthly drawings.
- The gift card is redeemable by email. No exceptions apply.
- When you host a virtual blood drive as an extension of your on-site blood drive, successful donations will be added together to calculate the total number of first-time donors. (Contact your donor recruitment representative to add a virtual blood drive to your on-site drive. It allows members of your community to give blood on behalf of your group at any Vitalant location.)
- Results of a virtual blood drive will be combined with the results of an on-site blood drive when applicable, resulting in one entry when the first-time donor target is reached. Donations made to the virtual blood drive must be made in the same month as the on-site blood drive to qualify for the monthly drawings.
- The total amount of first-time donors will be calculated after the blood drive is complete.
- The total amount of first-time donors must be at least 20% of the total donations made at the on-site blood drive, virtual blood drive or a combination of the two, to qualify.
- Vitalant tracks first-time donors based on successful donations.***
- The person designated in Vitalant's blood drive planning database as the 'primary coordinator' for the blood drive is eligible for entry.
- Primary blood drive coordinators who meet the criteria are automatically entered into the random drawing. They do not need to opt-in to participate.
- 5 primary blood drive coordinators will be randomly selected at the completion of each month of the campaign.
- Gift card winners will be notified by phone and email. They will have 7 business days to respond and claim their gift card. Following 7 business days, the gift card will be considered declined and a new recipient will be selected.
- A blood drive coordinator is eligible to win one gift card per month. A blood drive coordinator is eligible to win more than one gift card throughout the campaign timeframe.

**The total percent of first-time donors only includes completed donations and must be at least 20% of the total donations collected to qualify for entry, except in New Jersey, Ohio and Philadelphia. See below.*

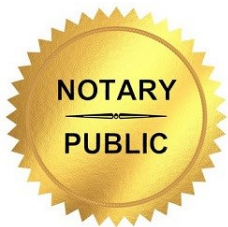
