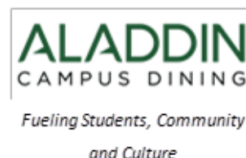

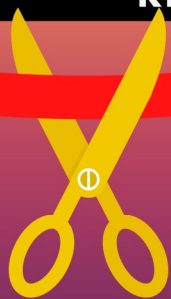

Greene County Health & Wellness Foundation



IN THE NEWS

On March 24, 2023, the Greene County Memorial Hospital officially changed their name to Greene County Health and Wellness Foundation. Formed in October of 2005, proceeds from the sale of Greene County Memorial Hospital created the Foundation. At the time, the board of directors thought it best to

keep the name of the former hospital (now known as Washington Health System Greene) as the new name of the Foundation.

However, over the years, having “hospital” as part of its name has always created confusion between the Foundation and the hospital. The Foundation’s mission has always been to support Greene County nonprofit organizations that are conducting healthcare initiatives. It raises money through donations and special events such as the annual golf benefit and Harvest Ball. It has no formal relationship with the medical facility, other than accepting grant proposals as it would from any other qualifying nonprofit located in Greene County.

In turn it provides funding to a multitude of organizations in the form of purchasing advanced medical equipment, capital improvement projects, camps for children, and operational costs for various projects as well. Along with funds dedicated to organizations, it has provided scholarship and tuition assistance awards to more than one hundred individuals pursuing healthcare degrees.

Just a few of the organizations that have received funding over the past fifteen years are United Way, American Cancer Society, Greene Arc, Cornerstone Care, Corner Cupboard Foodbank, Community Foundation of Greene County, Catholic Charities, 2nd Sam 9, Variety the Children’s Charity, Children’s Bible Ministries, and Coalition for a Brighter Greene.

The Foundation has also supported each of the five school districts in Greene County, along with the Career and Technology Center of Greene County and Intermediate Unit 1. Other noteworthy local organizations receiving significant funding are Washington Health System Greene, Waynesburg University, and HEADSUP, the nonprofit arm of EMS Southwest.

And while these approved grants have totaled well over two million dollars, the Foundation has always looked to make an immediate and significant contribution to the health and well-being of its community. Thus in 2017, it opened the EQT REC Center, located in the Greene County Industrial Park. The 60,000 square foot facility contains an artificial turf soccer field, basketball courts, pickleball courts, a large fitness facility, an indoor elevated walking track, community rooms, party rooms and a conference room. In addition to holding sports leagues and tournaments, any of these areas can also be rented out for athletic or special events.

Never satisfied with simply maintaining its contribution to the area, last year the Foundation took over the complete operation of the Cherry Door, a thrift shop located in downtown Waynesburg that provides clothing and goods at minimal costs. When Washington Health System Greene let it be known that it wanted to focus solely on providing top notch medical care in Waynesburg, the Foundation agreed to keep the doors open because it was acutely aware of the vital service it provided.

The Foundation is governed by a volunteer board of directors that meets on a quarterly basis to review the operations of the Foundation, the EQT REC Center and the Cherry Door, as well as any grant proposals. It is always looking for new and creative opportunities to improve the lives of Greene County residents and welcomes donations at any time. 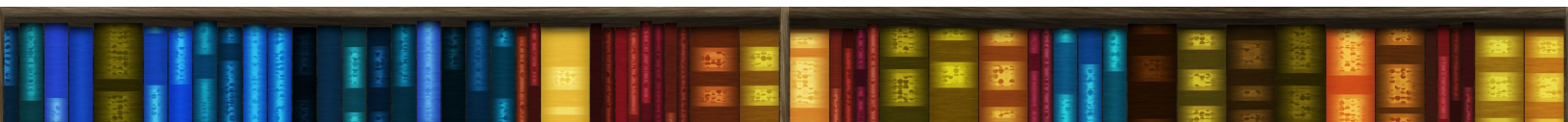

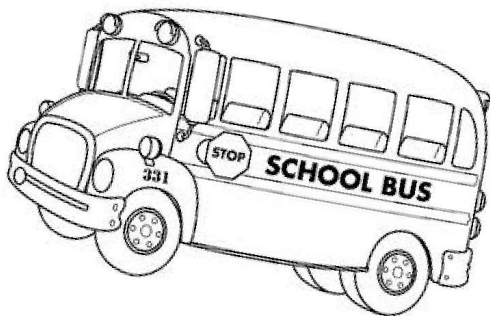

The Employee Retention Tax Credit

The Employee Retention Tax Credit (ERC) is a little known, under-used credit that includes funds to help business owners who kept W-2 employees on their payroll during 2020 (Q2–Q4) and 2021 (Q1–Q3).

- Up to \$26,000 per W-2 employee
- ERC is a refundable tax credit (it is not a loan like PPP)
- No restrictions on use
- No limit on funding
- On-site qualification

Getting this money to the businesses in Western PA can have a huge impact in our region.

Due to the complicated roll out of the program and few CPAs that process the paperwork, many businesses have not applied for this credit. I've partnered with a reputable firm specializing in tax credits to help local business owners complete the required forms.

The Employee Retention Credit was introduced in March, 2020, and allows up to \$26,000 per employee to businesses that qualify. This community workshop is free and open to the public, so please take advantage of the opportunity, especially if you have between 1 and 100 employees.

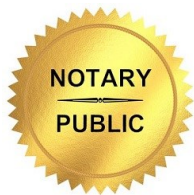
