### Dr. Benson Takes Reigns as New Year Begins

New ED Medical Director, Board Certified in Emergency Medicine

On January 3, Dr. Scott Benson, assumed the medical directorship at Southwest Regional Medical Center's emergency department. Dr. Benson replaced Dr. Michael Owens, who left last month to assume a position in North Carolina.

Prior to working with Southwest Regional Medical Center, Dr. Benson was an emergency physician for Monongalia General Hospital in Morgantown, WV. He is board certified in emergency medicine and is a Fellow of the American College of Emergency Physicians. Dr. Benson is a clinical instructor for the WVU Department of Emergency Medicine and Medical Director of EMS for Monongalia County WV.

"I am so impressed with the progressive environment of the emergency department and I look forward to being part of it all," shared Dr. Benson. "There is incredible commitment from the doctors, staff and EMS providers in the county to offer the best care possible for this community."

One of Dr. Benson's first goals is to fine tune the EXPRESS CARE program in the emergency department. This program is designed for those seeking care for less severe ailments such as colds, flu, sprains, strains and ear infections. The goal is to have patients in and out in less than an hour. Many EXPRESS CARE patients are treated by a physician assistant and overseen by the attending emergency department physician. In addition to Dr. Benson, two new full time physician assistants will be starting later this month.

"We are very committed to making EXPRESS CARE the best that it can be. We pledge to offer fast, convenient and, most importantly, quality care for our community," continued Benson. "We are grateful to the community for the success of the program and appreciate the support offered throughout this transition."


Another goal is to fully implement a new STEMI (ST Elevated Myocardial Infarction) Management System in conjunction with EMS Southwest. The STEMI Management System is a program designed to significantly reduce the time it takes for patients experiencing a heart attack

to receive appropriate treatment during the critical early stages, when treatments are most effective.

The program allows EMS Southwest providers to wirelessly transmit EKG's to the physician at the hospital before even leaving the patient's home. The physician will direct the paramedic as to the best option for treatment. If a heart attack is suspected, plans will be made to facilitate the patient's admission to an appropriate treatment facility for catheterization. Although chest pain is one of the most common complaints of patients presenting to the emergency department, only 10-15 percent of patients with chest pain are actually suffering from a heart attack.

"I have worked with the STEMI Management System for a very long time and have seen it save many lives," shared Benson. "Greene County will be one of the first counties in the state to offer this level of care."

Southwest Regional Medical Center is a 69-bed community based hospital with a full service emergency department. In January 2008, EXPRESS CARE was added as a service of the department. EXPRESS CARE was established to treat sprains, strains, flu, colds, ear infections and other minor ailments. Most patients are in and out in less than one hour.

### Rev. Bernice King, Daughter of Dr. Martin Luther King, Jr., to Speak Feb. 17 at WCCC

Presentation sponsored by Saint Vincent, Seton Hill, WCCC & the Community Foundation of Westmoreland County

Three area colleges are sponsoring a presentation by Rev. Bernice King, the youngest daughter of Dr. Martin Luther King, Jr., at 7 p.m., Tuesday, February 17 at the Westmoreland County Community College gymnasium, which is open to the public.

As part of a celebration of Black History Month, King will present the keynote address, "To Whom Much is Given, Much is Expected." The event is sponsored by Saint Vincent College, Seton Hill University and WCCC with a grant from the Community Foundation of Westmoreland County.

King began her public speaking career at age 17 when she addressed the United Nations in her mother's place. An ordained minister, she is the author of "Hard Questions, Heart Answers," a collection of her sermons and speeches.

King has spoken at the White House and in venues across the United States and abroad. A graduate of Spelman College, she holds a master of divinity and law degrees from Emory University. She worked as a law clerk in the Fulton County Juvenile Court system.

She has served as mentor to fifth grade girls at an inner-city Atlanta elementary school. She has coordinated non-violent conflict resolution conferences, taught a yearlong leadership development course at an Atlanta church and conducted a class on race relations at Mississippi College.

King has been featured on such shows as "Oprah," "BET Talk with Tavis Smiley" and the "Judge Hatchett Show."

A book signing will follow the presentation.

### PFEW Battles "Doom & Gloom!" |



An exciting, one-of-a-kind program open to all area 10th and 11th grade students will be celebrating thirty-one years of quality educational opportunities for Pennsylvania youth this summer. That program, Pennsylvania Free Enterprise Week (PFEW) is completely funded, taught and staffed by practitioners from the Pennsylvania business and industry community.

With all of the economic doom and gloom lately, PFEW has taken on even greater importance and significance. Said John Trombetta, president & CEO of the Foundation for Free Enterprise Education that presents PFEW each year, "I have rarely seen young peoples' attitudes more cynical or discouraged about business and business people as I do when talking to students these days. The mismanagement at some of our major financial institutions, coupled with what might normally simply be a downturn in our economy, has led to widespread mistrust and negativity among our youth in business generally. Fortunately, PFEW can completely transform those attitudes after a young person spends seven days with some of Pennsylvania's outstanding business men and women."

What John says is proven by the survey results of the 2008 PFEW graduates. Of the nearly 1,800 who attended, 94.4% indicated that PFEW had changed their perception of business; 96.4% reported that PFEW would be helpful in choosing their career; 97.9% reported that they had a better understanding of the American free enterprise system; and a whopping 98.8% indicated that their scholarship sponsors' money had been well invested.

PFEW now runs five individual sessions in July and August. (Sessions held either at Lycoming College or Penn College, both in Williamsport, PA.) Each participant is assigned to be a member of a "management team" operating a computer-simulated

"company" for the equivalent of three years. During that time they make all of the decisions any real-life business person would make and these fledgling entrepreneurs work with balance sheets, profit & loss statements, market share surveys, etc. To add realism, they are competing against two other student "corporations" manufacturing and distributing the same product. (PFEW is designed to give every participant, in broad brushstrokes, an idea of what is happening in the world of business today and what needs to happen in order to create and maintain a "business-friendly" environment.) The students hear speakers from all over Pennsylvania talk about subjects including: Business and Finance, The Role and Relationship of Business and Government, Taxation, Labor Relations, Business Ethics, and much, much more. Does it work? Consider the following quote from Ms. Cathy Lee McNeill of Newtown Square who said of her PFEW week, "I can honestly say this was the most life-changing experience I have ever had - in the space of only one week, I feel like I have learned more than a year's worth of class at school!"

The Chamber is proud to support PFEW and encourages our local companies and civic organizations to provide sponsorship for our area students and, if possible, perhaps even volunteers for the sessions. (PFEW is totally taught, staffed and sponsored by the Pennsylvania private sector.) Each student attends PFEW on a fully tax-deductible \$525 scholarship (the actual value of the scholarship is \$1,500) which is provided by a local firm or organization. The students wear the sponsors name during the program and all scholarship providers are recognized in a variety of ways for their support. Students write to their sponsors following the program to report on what they have learned. PFEW is also an approved organization through the PA Educational Improvement Tax Credit (EITC) program through the Department of Community and Economic Development.


