
LIPPENCOTT ALPACAS BREEDING FARM AND FARM STORE

Here a Hum – There a Hum. Everywhere a Hum-Hum!

Yes, alpacas make a humming sound that is soft as a baby's cooing or it can be a loud alert sound to signal the others about danger. Most of the time, they are as happy as contented cows and don't make a sound. Touch their luxuriously soft fleece and you think you are in heaven. Just look into their sweet faces and let yourself fall in love. The morning feeding begins for six hungry females

and two males. The boarder male with his big brown eyes hums as if to say, "I'm here!" Each alpaca gets a separate bowl and seems



to appreciate the personal attention but will always look longingly for more grain. We watch and admire them as they enjoy their grain and fresh hay. This is only part of what our daily "job" involves but we look forward to going to work. Life is good.

Philip Galing retired from the US Military in Germany after 24 years of service. Lena Hawkins Galing was a teacher in Germany and the states for years. She also worked in companies and government positions. We had great memories of the many places, people and experiences, but the "daily grind" was grinding down our spirits. Back on Lena's family farm in Lippencott, life changed overnight when we brought our first five female alpacas home in November 2005. The next spring, our first Greene County male named Dumbledore was born and then came another handsome male named Sterling a week later. Last September 11, 2007, an adorable white female named Lippencott's Moonshine was born. (Shine from the moon - of course) She is very curious and loves attention. She is gently becoming halter trained in preparation for two large alpaca shows this summer. The farm is also expecting three babies (crias) this summer. Farm tours are always free. Just call first so we don't miss a visitor. Reservations for groups are encouraged.

Last September, we hosted our first Open House during the National Alpaca Farm Days. We also officially opened our own Lippencott Alpaca Farm Store featuring attractive alpaca sweaters, scarves, socks, hats, gloves, blankets, throws, stadium seats, stuffed bears & alpacas, children's products and other unique items! We are growing more successful. The event offered a variety of educational activities and light food. A local hand-spinner named Joan Byrne demonstrated her spinning and knitting talents. Lena, surrounded by her alpacas near the back fence, presented details and information about the "girls". They impressed everyone with their gentleness and curiosity. They loved eating grain out of the hands of the children and fascinated onlookers. Our event placed in the top 3%

SOUTHWEST REGIONAL MEDICAL CENTER

Performs First Bilateral Knee Replacement

On February 20, Robert Plumley, 66, became the first bilateral knee replacement performed at Southwest Regional Medical Center. This procedure involves the replacement of both knees during one surgery. The replacement was performed by Dr. Armand Avolio of Tri-County Orthopedics Plumley decided to have the procedure due to a loss of motion and extreme pain. "My pain started to prevent me from doing things I enjoy, like golf and fishing," shared Plumley.

Plumley benefited from femoral nerve catheters. Femoral nerve catheters provide continuous pain relief for up to four days. Femoral catheters are offered to eligible knee replacement candidates. "With the pain medicine, I was up and walking the very next morning," said Plumley.

Prior to surgery, Plumley was admitted to a special orthopedic care room, complete with Comcast On Demand and music therapy. He and his wife stayed there until he was taken to surgery. He was brought back to this room after his procedure and will stay in the same room throughout his recovery where he will receive physical therapy services.

The Orthopedic Care Center provides knee and hip replacement candidates a full complement of amenities and services during their stay including, state-of-the-art pain management, luxurious accommodations, talented surgeons, caring staff, room service and even a massage treatment. The surgical staff includes Dr. Armand Avolio and Dr. Joseph Stracci of Tri-County Orthopedics.




