Tri-County Oil & Gas Expo



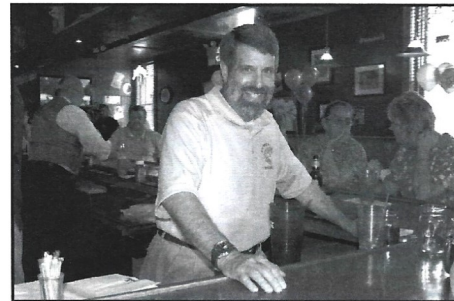

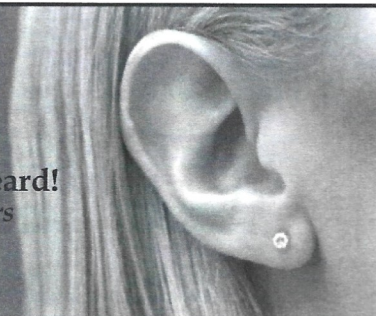

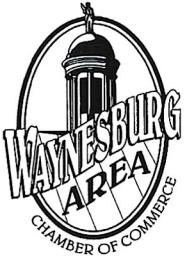
