PRISON UPDATE

Jean Mears, Assistant Superintendent, SCI Greene, spoke at our General Meeting March 27th and reported SCI Greene has passed infancy and is now going through the puberty stage of the institution. Currently they have 566 employees and they still have approximately 65% who have been hired from the Tri-County Area. Of the five institutions built SCI Greene still has the highest percentage of local hires. Inmate count 1393. Currently building an L-2 work camp on the outside perimeter by the institution. This facility will house minimum security inmates; the same type of inmates that Waynesburg institution has within their facility. They will have approximately 148 individuals housed in this unit . . . they will be their workers. They will be the inmates who work outside the institution. Inmates who will work within the community on projects. As an example of a project that have been presented to SCI Greene, is work on concession stands for ball fields and environmental cleanup. If you have anything you feel needs to be done in the community, don't hesitate to send a letter to Superintendent James S. Price. They don't have the inmates out there at this time and have not been working on outside projects; however, suggestions are welcome.

They have the highest amount of capital cases at their institution. Of the capital cases and inmates on death row, Jean deals with about ninety (90) of them and works with

attorneys in our community. With the inmate population they also have the largest restricted housing unit area. They have it almost entirely filled and that is where they place the "worst of the worst of the institution" the ones they have trouble controlling, that don't adapt to the environment they are in, so they are better off in this unit where they are better controlled. They are out of this unit approximately one hour a day for exercise. Weekends they are not out at all. They still maintain control at SCI Greene. A Commissioner came out and visited their institution and was highly impressed with management and control, as well as the type of individual they have been sent. Basically what has happened is that all of the institutions in this system wanted to get rid of those that are difficult. SCI Greene has been the recipient of the "pains of the system," who are very difficult to deal with. The L-2 Camp will probably open sometime this spring. Once this is open they will reach about 1700 inmates. They will then build two more units and eventually the population will be about 2300 and their employee count will go up as well. They established a Citizen's Advisory Committee from the County who sit, talk and discuss the institution so they can come back out into the community and inform the citizens. They have trainee testing and, for anyone who has a son or daughter who has applied, they will be advised within the next two months, at which time they will be pro-

cessing applications, according to their scores. They have a correctional industry program ... inmates are making "jeans" and they are talking with a retailer about selling these jeans. It is important to keep these inmates occupied. They are working diligently to help promote a drug-free institution. They have many inmates who are in for drug charges and drugs are a difficult problem in institutions. Some inmates are working on an outreach program to send out to various schools, talking about drugs and drug usage ... why they are in SCI Greene. This is one area of activity in which some inmates wanted to participate. They are seeing a lot of younger inmates coming in who have a very difficult time with authority figures. Therefore, the older inmates are working with authorities on video, etc. to help educate our young persons regarding the dangers of drugs. They are now using canine dogs at the institutions . . . they are brought in unannounced . . . as visitors come to institutions they are walked through and this has been somewhat successful in detecting drugs. However, it is a constant, and baffling problem at all institutions. Jean answered questions - sat after the meeting and talked with members and was a comfortable, articulate speaker... Thanks Jean for sharing your time and knowledge with us . . . we enjoyed your presentation very much and look forward to welcoming you back to share further information with us.
