I would like to begin this letter by apologizing for my negligence of replying quickly. When this letter arrived I was still in school in Kentucky and my family was also undergoing a move. Your letter was mixed up in the shuffle and I did not receive it until recently. Since receiving the scholarship I have gone on to study elementary education at Berea College. This is a small liberal arts school in Berea, KY (approximately 45 minutes south of Lexington).

I am about to enter my forth year of study and I am currently carrying a 3.78 GPA. My program is a five-year program so I still have two more years of study. While at school I am employed as the Residence Hall Coordinator for Kentucky Hall, an upperclass men's dormitory. Through this leadership position I coordinate a staff of five Residence Assistants. As a team we facilitate activities, programs, etc. for the hall. I have been named to the Dean's List several times over the past three years and I was recognized this past semester with the Dr. Lee E. Wickline Scholarship. This award is for showing educational excellence through leadership.

I am working this summer at the Pressley Ridge School at Ohio Pyle as a Teacher/Counselor. This is a residential institution that services approximately 60 troubled youths from around the state. There are six different groups and campers take an average of twelve months to matriculate through the program. The program utilizes experiential learning in an attempt to re-educate its campers. I will be

leaving to go back to school at the end of August.

Your scholarship was very essential to my success over the past three years. I used the money to purchase a computer just before going off to school. I have used and will continue to use it to prepare papers for class, resumes, documents for work, etc. Having a computer in my room has allowed me to do my work when it is convenient and most effective for me, without having to conform to computer lab hours. I would like to take this opportunity to thank you again for your generous contribution. It has been very helpful to my college career and ultimately my development personally.

Suzanne Huffman reported that the Revitalization committee has received the pricing for the building plaques, the medallions, installation and is waiting on a price for the historical research. As soon as that is finalized, flyers will be distributed to all business owners and property owners in the downtown area. She also thanked all the support received from the business community who helped make this event happen.

OLD BUSINESS: The Welcome to Waynesburg sign has finally been moved and looks very nice. The Southwestern PA Girl Scouts has

contacted the office about joining so that they may place a logo on the sign. The art work for the 2000 Christmas Bulb has finally been secured. It will celebrate the 75th anniversary of the Historical Society. The bulbs should be ready for sale in September.

NEW BUSINESS: A request for a donation for Cary Kolat's Olympic quest was received. It was announced to the membership for individual donations as is our policy. An open invitation for members to attend the Waynesburg House Open House to be held on August 9th was presented and the members were encouraged to attend.
