

SPEAKER: John introduced Timothy Thyreen, President of Waynesburg College. President Thyreen proceeded to inform the Chamber of the many positive things happening at Waynesburg College. The College has raised over ten million dollars for capital improvements. With that economic effect translating into twenty-five million dollars for southwestern Pennsylvania. Waynesburg College students perform over eight hundred hours of community service per week. The newly renovated back

campus "quadrangle" will be formerly dedicated on the College's Charter Day, March 21. At that time ground breaking will also be held for the new college theater. The public is invited to attend. Plans are to renovate the College library and to build the Frank Wolf Field House at the College football field. President Thyreen also told those in attendance the College is continuing to bury utility cables. Waynesburg College has donated \$10,000 to the Waynesburg Parks Commission for lighting of the parks. He also informed the membership that the Richard King Mellon Foundation gave \$300,000 to fund service projects for Waynesburg College students. From President Thyreen's presentation the Chamber members were made aware of the myriad of projects happening at Waynesburg College.

ADJOURNMENT: On a motion made by John Loeper and seconded by Clark Patterson, the meeting adjourned at 12:45 p.m.
