Ralph Peacock began practicing law in Washington County in 1925. Since that time the firm has grown to become an organization composed of ten partners, three associates and two senior attorneys serving as "of counsel." The primary office is located at 70 East Beau Street, Washington, Pennsylvania. There is also a network of offices located in Bridgeville, California, Claysville, Peters Township and Waynesburg.

The Waynesburg office was opened on January 1, 1987 under the local management of Mary K. Pruss, Esquire, Mary had been practicing law in Greene County since her graduation from the West Virginia University College of Law in 1980. She had previously served in the office of the Greene County District Attorney since 1981 and as solicitor for the Domestic Relations Office of the Court as well as developing a general practice of law. She had also served two terms as the President of the Greene County Bar Association.

Mary was made a partner in the law firm on January 1, 1993 and continues to practice orimarily in Greene County but also handles cases in Washington County and in the Federal Court System.

One of the reasons for the stability and success of the firm has been the flexibility which the firm offers to its clients. The firm

was able to mobilize additional manpower to perform the most complex real estate or mineral law transactions and at the same time successfully represented clients in matters as diverse as anti-trust litigation to the level of the United States Supreme Court and family practice at the local level. Each of the various partners have developed expertise and achieved recognition for leadership in various fields including school law, labor law, construction law, health and hospital law, probate and estate planning, corporate and business law, personal injury law and family law.

Mary also has been active in the local Waynesburg community over the years, initiating the Greene County Victim/Witness Policy Board, serving on the Board of Directors of Care and as a member of the Waynesburg Lions Club where she became their first woman president as well as giving her services to the Waynesburg Area Chamber of Commerce.

Mary has been married to Stanley W. Pruss for 35 years and they are the parents of four children and grandparents of one grand-child. Stan and Mary own three farms where they primarily grow Christmas trees. In their spare time they enjoy hiking and canoeing.
