Greene County Memorial Hospital

Serving Greene County and the surrounding area since 1907, Greene County Memorial Hospital's mission is to provide a continuum of health services in a cost effective manner.

The Hospital has many departments which use state-of-the-art equipment to provide both inpatient and outpatient services.

The fourth floor of GCMH was redesigned as a Skilled Nursing Unit for transitional care. 20 attractively decorated private and semiprivate rooms were created to serve as a means to prepare a person for returning home after surgery or a debilitating illness. Patients can be transferred from the acute care section of the hospital to the SNU for an individualized rehabilitation program which could include physical, occupational and/ or speech and hearing therapies. Having this unit located in our County has afforded many of our residents an opportunity to recuperate fully and return to their homes ready to experience a fuller and more dignified life. While in the SNU, the residents are encouraged to dress as they would at home, and with the help of the Activities Director, to participate in many of the same activities as they would in their own home. The SNU offers the resident, as well as their family members and friends, the peace of mind in knowing that the entire services and staff of the Hospital are there, if needed. Barbara Girod is the Nursing Home Administrator, and Diane Granus serves as the Director of Nursing.

The Hospital's fifth floor houses the Center For Geriatric Psychiatry, which was dedicated and opened in June, 1996. An older adult with serious mental illness may suffer from an array of physical and emotional problems. For example, depression or anxiety can be complicated by infections or prescription medications. With these complexities in mind, GCMH's Center For Geriatric Psy-

chiatry specializes in comprehensive inpatient care in a secure, home-like setting. As Greene County's premier provider of gero-psychiatric care, the Center for Geriatric Psychiatry provides full diagnostic and treatment services to the patient while providing support and assistance to the family. All referred patients are screened for admission by the Patient Care Coordinator and Medical Director. In general, patients must meet three criteria: 1) Have a primary psychiatric diagnosis requiring acute inpatient treatment; 2) Be able to participate in the therapeutic milieu and treatment program; and 3) Be 55 years or older, or have problems common to the older adult. Scott Roberts serves as the Program Director and Lori Lasosky as the Nurse Manager.

Also located on the fifth floor is the surgical Short Term Procedure Unit which was opened in 1995. A ten-bed unit, located just outside the operating room suite, certainly simplified the surgical process for the physicians, employees, and most importantly, our patients. From the time of admission, to the point of discharge or when recovered and admitted to an acute care bed, all the activity occurs in one area. Shirley Shannon is the Nurse Manager for STPU, while Mary Lee Headlee serves as Surgical Services Coordinator. Cardiac and Pulmonary Rehabilitation are services that moved into their new location on the Hospital's 1st Floor in 1995, also. The Cardiac Rehab patients will hold an anniversary picnic later this summer to get reacquainted and chart each other's progress.

Coming soon to GCMH is a bone densitometer, which will be located on the 4th Floor next to the accredited mammography unit. This equipment measures bone density and will help to diagnose those persons who are suffering from osteoporosis, which can now be treated.

Osteoporosis is labeled a "silent disease" as it often goes undetected until a fracture occurs. This disease occurs more often in post-menopausal women than men. It is estimated that more than \$6 billion dollars per year are spent treating hip fractures, a large percentage of which are caused by this disease. This examination will be a service of the Diagnostic Imaging Department.

An attempt has been made to highlight a few of the new programs and services offered locally at GCMH. Medical education programs for the public are offered free of charge throughout the year and we welcome your suggestions for topics of interest. Support groups that have been organized by Greene County residents meet regularly in the Hospital. 
