Celebrating the Arts Planned for July

President Suzanne Huffman called the meeting to order at 12:25 p.m. Introductions were made around the room and Nancy Dryden introduced guests who are completing their studies at Waynesburg College as part of the International Studies Program. On a motion by Susan Stoy, seconded by Mary Pruss, the minutes of the previous meeting were approved. On a motion by Katy Shultz, seconded by Connie Clark, the Treasurer's Report was approved. On a motion by Millie Wonderling, seconded by Jeanine Henry, the Secretary's Report was approved.

COMMITTEE REPORTS: Susan Stoy reported that 13 teams took part in the Chamber Golf Outing which was won by team WANB in a putt-off against First Federal. Both teams tied for the top spot at 12 under. 86 prizes were donated by Chamber members and given to those present. A final financial report is being prepared and will be presented at the next meeting. Suzanne Huffman reported that the Revitalization committee is proceeding with the incorporation process and is working on completing the proposal for the historical plaques. The cost of the plaques will include the plaque, its installation and the memory medallion. At an additional cost, building owners who have not researched their building's history can have the research done. Sheila Barger reported that the Miss Rain Day Pageant committee is making final plans for the pageant which will be held on July 23rd. They are making an effort to cut the running time of the pageant down this year.

OLD BUSINESS: Suzanne Huffman reported that the final approval to move the

NEW BUSINESS: The Greene County Historical Society was chosen at the June Board of Directors meeting to be the subject of the 2000 Christmas Bulb which is the fourth in a series. It is hoped that the bulb will be available by Rain Day. Suzanne Huffman reported that she and Jackie Kingora have become members in the Pittsburgh Regional Alliance which promotes Southwestern PA as a place to live and work. They are currently seeking others from the area to join the Alliance in an attempt to better promote Greene County.

Suzanne Huffman introduced Mr. Larry Celaschi, Contracts Specialist with the Bureau of Contracts and Public Records. He reviewed the process and contacts needed to obtain state contracts for small businesses. Funding sources are also available for small businesses to expand in order to obtain contracts. Many small contracts under \$10,000 are available as well as larger ones. A company can choose to bid on only those contracts that fall within their geographic region or statewide. Over 75,000 contracts are awarded for everything from computers to road kill removal services.

On a motion by Jeanine Henry, seconded by Susan Stoy, the meeting was adjourned at 1:00 p.m.

Comply with COBRA

The Consolidated Omnibus Budget Reconciliation Act (COBRA) was passed to provide employees or former employees, their spouses and dependents with a temporary extension of group health insurance when coverage is lost due to certain "Qualifying Events." COBRA must be identical to the coverage provided to similarly situated active employees. All employers who had 20 or more employees "on a typical business day" (50% or more of the business days) during the preceding calendar year must comply with COBRA.

As of January 1, 2000 a change was initiated in the way the number of employees is determined. Now an employer may determine the number of employees on a daily or pay period basis. The basis used must be the same for all employees and must be used consistently throughout the entire year for which the determination is being made. Each full-time employee counts as one employee and each part-time employee counts as a fraction of one employee. The numerator in the fraction is the number of hours the parttime employee works and the denominator is the number of hours an employee must work to be considered full-time. In no event may the hours required to be a full time employee exceed 40 hours for any week. So, if a fulltime employee is deemed to work 40 hours and a part-time employee works 30 hours, the part-time employee is counted as 3/4 employee (30 hours/40 hours) for COBRA

Here is an example to show the calculation to determine number of employees for

Company A has 10 full-time employees. Full-time hours are designated as 36 hours per week. Company A also has 40 part-time employees. Each part-time employee works 9 hours per week. Each part-time employee is counted as 1/4 employee (9 hours/36 hours), 40 multiplied by 1/4 is equal to 10 employees, plus the additional 10 full-time employees equals 20. Thus, the company must comply with all COBRA regulations because it would be deemed to have 20 full time employees.

An employer member of Chamber Choice may administer COBRA either in-house or through EBDS, the billing department for ChamberChoice. If you have questions regarding COBRA you may call the ChamberChoice administrative Team at 1-800-377-3539 or EBDS at 412-394-6311.


