MEMBERSHIP PROFILE

FIRST FEDERAL

The strength of First Federal Savings and Loan Association of Greene County has once again continued to grow and remain very healthy. With \$410 million in assets and 65.9 million dollars in net worth, First Federal's capital ratio is now at 16.06 percent, more than five times the regulatory requirement.

First Federal Savings and Loan Association recognizes the need to insure the safety of its depositors and has pledged to continue its efforts to keep them in a very comfortable financial position. For the 36th consecutive quarter, First Federal Savings and Loan Association was awarded a Five-Star Rating from Bauer Financial Reports. Bauer has rated financial institutions for safety and soundness since 1988, and First Federal has been rated five stars each quarter since. Most of the nation's largest banks failed to earn a five-star rating in the most recent reporting period.

In 1997, the association closed 71 million dollars in mortgage loans. Those loans helped 1,102 families buy or build a home. Home mortgages are the best and safest security for a loan. For each dollar that goes into housing, three more dollars are generated. The association is, therefore, responsible for placing \$213 million into the Greene County

and surrounding communities' economy. This is one more indication of the dedication of First Federal to community banking.

In March 1997, the association entered the debit card market by introducing its MAC customers to the Visa debit card. This has been a great success and as of the year's end, over 2,790 customers had obtained the Visa debit card. In August 1997, a giant step was taken toward improving their data system by installing new software through their data center at FiServ in Milwaukee. Although there were some rocky roads traveled between August and December, the new system gives First Federal's personnel extra tools to help better serve its customers.

The year 2000 issue has been publicized quite frequently and First Federal of Greene County has and continues to take all the necessary steps to be completely prepared for the year 2000. Management assures our customers that we will be ready and our service will go uninterrupted as it has for the past 74 years.

First Federal is looking forward with great anticipation to the 75th anniversary of our institution which will be celebrated in 1999.




