Work on Group Health Care Plan Continues – Letters of Interest Needed

Our Chamber is joining forces with 39 other area Chambers of Commerce to offer their member firms Blue Cross group health care and other employee benefits. Through the Chambers of Commerce Service Corporation, member firms can choose one of four Blue Cross/Blue Shield plans in addition to group life, short and long term disability, and dental and vision coverage. There is no medical underwriting restrictions for preexisting conditions and plans are available to firms as small as one person.

An informational mailing was sent recently to all members on the various plans offered. Companies interested in joining the plan should send a letter of interest to the Chamber office as soon as possible. We must collect 35 of these letters in the near future to be able to enroll in the program. The letter must be on company letterhead, state the number of full-time employees, the name of each employees' current health care provider and their policy number if any.

Educational Fund Scholarship Applications Are Available

We will be awarding our third \$1500 scholarship for a Greene County student this April. The criteria for consideration are as follows: must reside in Greene County, must be a graduating member of a class of 1993, must have been applied and accepted to a College of their choice as an incoming freshman in a four year academic program and must have maintained a cumulative grade point average of 3.0 or higher. Applicants must submit a listing of their community and local involvement and write an essay on "What is your purpose in life and how do you plan to address this purpose through your education?" Applications are now available from local guidance counselors or the Chamber office. Entry deadline is April 15th. The committee is chaired by Dick Robinson of Edward D. Jones & Company.

General Membership Meeting

President Tracy Burns-Suter called the meeting to order at 12:15 p.m. She welcomed everyone and asked for introductions around the room. On a motion by Jack McCracken, seconded by Mary K. Pruss, the minutes of the previous meeting were approved as written. Tracy Burns-Suter reviewed the financial report. She thanked Chas Huffman for the donation of a financial software program for the office. Melody Longstreth presented the Secretary's Report for January.

COMMITTEE REPORTS: Tracy Burns-Suter announced that the Policy and Procedure Committee has begun its work and policies will be brought before the membership for approval in the future. Dick Robinson reported that the Educational Fund Committee has completed its work until the applications are received on April 15th. He has spoken with the guidance counselors and many students are interested. Some interest has been shown for students entering two year trade schools who also wish to apply. However, under the current guidelines, only four year academic programs are eligible. After discussion, the President asked for a show of hands, based on the result, the program will remain as it is. Tracy Burns-Suter briefly reviewed plans for the Golf Outing on July 10th at Rohanna's. The entry fee was raised \$5 this year to \$130 for a four man team due to an increase in greens fees. Prizes are currently being solicited by Chairman Chad Moore and his committee.

OLD BUSINESS: Tracy Burns-Suter announced that an Insurance meeting was held recently with a low turnout. She reviewed what has transpired to date with the Insurance.

NEW BUSINESS: Tracy Burns-Suter announced that plans are being formulated for a debate between the candidates for sheriff and district magistrates in April. This type of event is a good publicity tool for the Chamber. Dick Robinson invited members to attend a free seminar titled "Revitalization of Main Street" on March 17th from 1 to 2 and 6 to 7 p.m. in his office.

SPEAKER: Tracy Burns-Suter introduced David Smith, a Regional Vice President with the firm White Nagle Mazza & Associates, Inc. based in Columbus, Ohio and William Mayberger, a principal and representative for the company in Western Pennsylvania. They spoke on "Why you need to know the value of your business." An estimated \$6-\$8 trillion of personal wealth will transfer over the next 10-20 years, a substantial portion of which is held by first generation business owners in the form of closely held stock. Because no ready market exists in which to

establish a reliable market value for these securities, each one in and of itself, represents a unique and challenging valuation problem in the eyes of banks, lending institutions, the IRS, qualified buyers, and the courts. Assistance is needed by many large and small companies spanning a wide spectrum of businesses, covering most major markets, industries and SIC codes.

ADJOURNMENT: On a motion made by Clark Patterson and seconded by Greg Rohanna, the meeting was adjourned at 1:00 p.m.
