## ALLTEL Plans Special Olympics Sponsorship for Summer 1999

President Mary K. Pruss called the meeting to order at 12:15 p.m. Introductions were made around the room. On a motion by Kay Laskody, seconded by Chad Moore, the minutes of the previous meeting were approved as written. On a motion by Jack McCracken, seconded by Shirley Stockdale, the Secretary's Report was approved as presented. Treasurer Richard Scott reviewed the Financial Report and on a motion by Chad Moore, seconded by Suzanne Huffman, it was approved as written.

**OLD BUSINESS:** President Mary K. Pruss presented the committee sign up sheet and passed it around the room. She encouraged members present to sign up to help with committee work. There were no additional old business items brought from the floor.

**NEW BUSINESS:** She introduced Lenny Evansck, a Bonor Scholar from Waynesburg College who is working with the Greene County Food Bank as a service project. He announced that on March 27th the Food Bank will sponsor the "March to end hunger," a two mile work to raise monetary support for the Food Bank here in Greene County. He encouraged the businesses present to recruit employees to participate as a team to walk and raise money. The walk will begin at the Waynesburg Armory and wind through the college campus and football fields. Prizes will be awarded to the top three fund raising teams. He also announced that the Food Bank has moved into it's new facility on Rolling Meadows Road. President Mary K. Pruss also reviewed the policy for members to place information into the monthly Chamber Chatter newsletter. She encouraged those

present to send in items on awards, new positions, etc. that they would like to publicize to other members. In addition, one advertising space remains open as well. Jack McCracken introduced Dr. Shannon Vissman who recently opened Vissman Therapeutics. Dr. Vissman joined the Chamber today and was welcomed by a round of applause.

**SPEAKER:** Timothy Hawfield, Waynesburg Borough Police Chief was introduced by Mary K. Pruss. He presented a history of police activity in Waynesburg. The first written record available was published in the Waynesburg Republican newspaper in 1855. It stated that James Cosgray, Constable, was paid 'per arrest'. He also gave a list of charges that could be charged by the Burgess - the forerunner to the District Justice. They were very humorous. He pointed out that in 1869 it was against the law to play cricket (baseball) within the borough limits. He has not found where that law was rescinded. A gentleman who was known as "Sparky" was the most arrested person in Waynesburg History being arrested usually for public intoxication.

On a more serious note, the force currently has eight full time officers and they make up the only police force in the county with the exception of the Pennsylvania State Police. At one time they had eleven full time officers, this was made possible with grant money. The force must always "sell themselves" to the public because the force is at the mercy of the public. The State Police will always be here but the local police forces are in place due to public desire. As a result of this, they are constantly evaluating themselves, their performance and their image. All officers pledge to conduct themselves in a fair, professional and appropriate manner at all times. Each officer is trained in field sobriety and Waynesburg has a reputation in the area of being a "tough" place for drunk drivers. Cameras are mounted in most patrol cars, they help officers when on duty alone as the first thing a suspect is advised of is the fact that they are being recorded. They collect evidence on drunk drivers and protect against officer misconduct. The force operates on a limited budget which is stretched as far as possible. They always strive to do the best job they can do on the resources they have. They are active in the Drug Task Force, the Women's Shelter and will soon be a part of Waynesburg College and Margaret Bell Miller Middle School. The children at the Middle School are of an age when they reach many crossroads in life and the hope of the force is that by going to lunch with the students and making themselves approachable, the chil-

dren may feel more comfortable in turning to them and possibly staying out of trouble. Parking enforcement is a big issue for the force, they have a parking officer whose responsibility it is to turn over parking spaces for potential customers. They plan to reline the parking spaces in the Spring and gain 8 to 12 spaces by doing so. Shoplifting signs are posted around town and as a result, there has been a decrease in shoplifting crimes.

Sheila Barger announced that the Raider Basketball Team is doing very well and has a big game on Friday night. She asked that business help show their support of the team by placing signs in their windows, messages on their billboards, etc.

The next meeting will be hosted by Nova Care on March 24th. On a motion by Chad Moore, seconded by Richard Scott the meeting was adjourned at 1 p.m.

## NEW LAW FOR UNCLAIMED AND ABANDONED PROPERTY

Barbara Hafer, State Treasurer would like to bring to your attention a law many businesses are not aware of and would like to offer the Treasury's help in ensuring that your business is in compliance with the law. The law is the Disposition of Abandoned and Unclaimed Property (Act No. 248 P.L. 1057 72 P.S. §1301.1 et seq), which the Treasury administers. The vast majority of businesses in the State are subject to the act, which requires that all holders of unclaimed property must file a report by April 15 of each year. Unclaimed property includes uncashed payroll or accounts payable checks, unredeemed gift certificates, credit balance, uncashed dividend checks, and stock or unredeemed coupon bond principal or interest held for seven years or longer. Other types of unclaimed property also exist and identified based on the type of business that generates them. If a company is not in compliance, the law provides for audits and for the imposition of penalties and interest charges. Ms. Hafer has made it her policy to encourage compliance through education, rather than punitive measures, whenever possible. If you are concerned that you may not be in compliance, the State Treasury office encourages you to contact them to learn how you may achieve voluntary compliance. Please call the Bureau of Unclaimed Property at 1-800-379-3999. You also may communicate with them by e-mail (mvessella@tre.state.pa.us or fax, 717-787-0432, and you will find additional information about unclaimed property and the law on the Treasury Department web site, [www.treasury.state.pa.us](http://www.treasury.state.pa.us).

# Retirement Plans Are For Small Businesses Too

A tax-qualified retirement plan offers employees an attractive means of saving for retirement and is an effective way for employers to get tax benefits. Unfortunately, small businesses don't always offer their employees any retirement plan at all due to the common misconception that such plans come with high costs and heavy administrative demands. Instead, employers encourage their employees to establish individual retirement accounts (IRAs).

But IRAs alone aren't always enough to help these employees retire comfortably, and small businesses are in danger of losing employees to larger businesses which offer more attractive benefits packages.

In order to attract and retain valuable employees, many small businesses now offer employees a Simplified Employee Pension (SEP IRA), SIMPLE IRA, Profit Sharing Plan or Money Purchase Pension Plan. These plans are relatively simple for the employer to establish and operate, and they needn't over-extend the resources of a small business. The employees enjoy a vehicle for tax-deferred growth of assets for employees.

The Simplified Employee Pension IRA, or SEP IRA, is very popular in the small business community because employer contributions are fully discretionary each year, and employers may take a deduction for the amount contributed on behalf of each employee. The contribution, if any, is not taxable to the participants until withdrawn. The self-directed SEP IRA offers employees the ability to accumulate more assets than possible through a Traditional IRA and to choose investments that meet their specific retirement needs.

The SIMPLE IRA is a salary deferral plan structured to eliminate many of the complex administrative requirements often associated with 401(k) plans. The SIMPLE plan allows for employee salary deferral contributions of up to the lesser of \$6,000 or earned income, made on a pre-tax basis. The required employer contribution can take the form of either a 3% match or a 2% non-elective contribution. While the burden of funding the plan is shared by employer and employee, the employer gets a tax deduction for the entire amount contributed on behalf of each employee. Investment earnings accumulate tax deferred until distributed from the plan.

The Profit Sharing Plan is a qualified retirement plan that allows for discretionary tax-deductible contributions of up to 15% of total compensation paid to all eligible employees. All contributions are made by the employer and the percentage contributed

can vary from year to year. With this plan, the employer retains the flexibility of excluding some part-time workers while the employee enjoys an employer funded benefit plan that offers the ability to accumulate more assets on a tax-deferred basis than possible through a Traditional IRA.

A Money Purchase Pension Plan is a qualified retirement plan established by an employer to allow for a tax-deductible contributions of up to 25% of each participant's total compensation. Employers thus benefit from the ability to contribute a greater percentage of compensation than is available in most other plans - an attractive advantage for the employer who may be attempting to maximize the dollars contributed on his or her own behalf. Like the Profit Sharing Plan, this plan allows the employer to retain the flexibility of excluding some part-time workers and the employee to enjoy an employer funded benefit plan that offers the ability to accumulate significant assets on a tax-deferred basis.

As you can see, there are many options for small business owners looking to provide a tax-deferred, employer-sponsored qualified plan. By establishing a retirement plan, you can effect a dramatic difference in tomorrow's standard of living for yourself and your employees.
