On a motion by Robyn Riggs, seconded by Kathleen Dukate, the Treasurer's Report was approved. On a motion by Kay Laskody, seconded by John Glass, the Secretary's Report was approved.

John Glass, chair of the Golf Outing Committee, reported that the Carmichaels Chamber of Commerce has placed the idea of a joint venture golf outing before their members. They had no one interested in participating with us on this project. He announced that we will keep the date of June 10th at the Carmichaels Golf Course and will proceed with planning the event ourselves. Anyone interested in helping with the project is encouraged to join the committee. Susan Stoy reported that Suzanne Huffman, chair of the Revitalization Committee is in Pittsburgh at this time attending a 'Grantmakers' seminar to learn more about the grant process to help the committee execute their plan. for the office. Bids are currently being accepted from members. Susan thanked Connie Clark from Kyowa for their donation of a hard drive to use in case the current office computer crashes.

NEW BUSINESS: Susan announced that the next Board meeting will be held on March 8th at Waynesburg College. She thanked the college for the opportunity to meet there. Pauline Crumrine introduced Christopher Staub, a new therapist at Nova Care's location. He will be the Chamber representative for their office.

Susan Stoy introduced Judy Loughman, Recruiting Manager for the 2000 Census. Getting people to respond to the Census is the biggest problem they face. An undercount can cost the county money in federal funds. In 1998, Greene county received money based directly on census figures. The School Lunch Program received \$856,000, WIC \$747,000, JTPA \$499,000, Highway Construction \$3,708,000 and Title One Education Grants \$1,948,000. It is estimated that each person not counted costs the county \$1,000 annually in federal money for the next ten years. Add those figures for a family of five and you can begin to see the importance of being counted. Currently, they are at 67% of goal for recruiting volunteers needed for census takers, office staff, special site workers, etc. The rate of pay is very good and the individual can still work their full time job and devote as many hours a week to the project as their time allows.

On a motion by Katy Shultz, seconded by Richard Scott, the meeting was adjourned at 12:40 p.m.
