The College will commemorate its 1850 charter and honor the students selected for this year's "Who's Who in American Universities and Colleges." Reverend Tim McCloskey, founder of Centurion Ministries, is the invited speaker for the event. Centurion Ministries, located in Princeton, New Jersey, has a mission statement to vindicate and free from prison those who have been wrongly convicted and imprisoned. COMMITTEE UPDATES

AUDIT COMMITTEE - Completed its review of the 2001 books of account for the Chamber. They found no discrepancies within the books. All monies are present and accounted for. They made the following recommendations which were taken into consideration by the Budget Committee. The Chamber should apply for a credit card for purchases that need to be made in that manner. This would eliminate staff and members from using their personal cards and then waiting for reimbursements. An officer should be asked to sign off on the monthly time-sheet for the office staff as an audit trail. Remove the event/committee income and expense numbers from the Operating Budget to reflect only the net income from each event/committee. Each committee would then be responsible for preparing and monitoring their own event budget. Supply purchases for an event/committee should be removed from the General Operating Supply line item to be placed into their specific budget and not the General Operating Budget. A formal signed copy of the audit is available for viewing in the Chamber office.

SPEAKERS COMMITTEE – No chair was chosen. The committee discussed several presentations and formal requests to speak by local community groups. It was decided to allow two to three community focused topics throughout the year with the remainder of the eleven speaking engagements being filled by business related topics. The calendar year

for this committee runs from February to February with no speaker needed for December. The planned topics for the next several months are; ChamberChoice Health Plan, Evergreen Technology Park, Pennsylvania T.A.P. Program, How to Bid on State Contracts, Vo-Tech Community Training Outreach and the Greene County Community Foundation. The committee will meet again in August to plan the remainder of their calendar.

GOLF OUTING COMMITTEE - Chair John Glass. The event date was set last year for May 17th at the Greene County Country Club. A players data base was begun last year and will be included with the chamber membership data base for the mailing of the brochure seeking teams. Costs were discussed as well as areas of sponsorship. Prizes and special events will remain the same. Discussion was held on offering windbreakers as the gift for all players this year. Door prizes will also be awarded again this year but with one change; names will be drawn during the tournament and posted so that as teams arrive back at the clubhouse, they may check to see if they have won an item. Individual ticket numbers will not be called in order to speed up that portion of the day. It appears that we will have a car donated to use as a hole-in-one prize.

BY-LAWS COMMITTEE – No chair was chosen. The group reviewed the existing by-

laws and will be proposing changes in the new future. Most of the items are minor in nature. The policies and procedures will also be reviewed and possible changes proposed. Both items are needed to apply for the Pennsylvania Approved Chamber status. All changes will be published in the newsletter prior to a vote being taken. The committee will meet again on March 19th at noon at Groovy's to hopefully finish the updates so that they may be published in April for discussion.

REVITALIZATION – The Revitalization committee has formally become Waynesburg Prosperous and Beautiful, Inc., however, it will be supported by the Chamber office until it is in a position to hire a manager and open its own office. The incorporation papers have been filed with the state and a 501(c)(3) is in the process of being filed. Each sub-committee is preparing a five year work plan. Once those two items are complete, the application can be filed with the Main Street Program and once approved, we will be eligible for start-up funding. The Board of Directors has been selected and they are; Charles Perrine, John Owen, Susan Stoy, Mike Murray, Brenda Giles, Mary Pruss, Terry Grimes, Scott O'Neil, Jay Hammers, Chuck Behm, Chris Kiger and John Glass. They have held their first meeting and elected the following officers; President-John Owen, Vice-President - Mary Pruss, Secretary - Chris Kiger, Treasurer - Susan Stoy.

College Students Participate in Revitalization Effort

One of the first steps in realizing our collective Vision for our downtown is to inventory what we have and identify potential opportunities. As part of Waynesburg College's commitment to the project, senior Marketing Management students, Tierza Barclay, Colin Haas, Mike O'Neil, Amanda Rameas, and Larry Steinhoff and Junior Andrea Lohr will be conducting a business inventory, a customer intercept survey and an on-campus survey. The customer intercept survey will be administered at select downtown locations and will help determine who comes to Waynesburg, why they come, where they spend their money and what influences their buying. Gathering and interpreting this data will help in the Economic Restructuring Committee's effort to retain and attract customers and businesses. The data will not provide any ready-made answers but will serve as a starting point for making decisions about the revitalization program's priorities and activities. Potential uses of the data to be collected include:

A fact sheet about local customers for local businesses.

Assist existing businesses to thrive by sharing information so they can adjust their current merchandise and expand into new lines.

Share facts with property owners and realtors so they can recruit appropriate businesses that have a good chance of succeeding in our local market.


Development of a business recruitment packet.




