## RAG

### RAG PENNSYLVANIA SERVICES CORPORATION

RAG Pennsylvania Services Corporation is the general partner of two operating coal mines in Greene County: RAG Cumberland Resources, LP and RAG Emerald Resources, LP. Both Cumberland and Emerald were developed in the mid-1970s and began full production in 1977. Each mine has been owned and operated by various companies until July of 1999, when they were purchased by RAG American Coal Company. Cumberland and Emerald are underground longwall mines with approximately 200 million tons of recoverable reserves. In 2002,

Cumberland and Emerald produced a total of 13.2 million clean tons. Coal from Cumberland mine is processed through a 1,600 tons per hour preparation plant. Cumberland's coal is then shipped by our own railroad to dock facilities enable Cumberland to market its coal throughout the eastern United States' navigable waterway system from the Monongahela River to the Mississippi River. Coal from Emerald is processed through an 1,850 tons per hour preparation plant to a silo and bin loadout facility. Emerald's coal is shipped to market via Norfolk Southern and CSX railroads.

## Regional Internship Center

The Waynesburg Area Chamber of Commerce has joined forces with the Regional Internship Center (RIC) of Southwestern Pa. The RIC has been created through the Three Rivers Workforce Investment Board to fundamentally change the way the internship system operated throughout Southwestern Pennsylvania. The goal is to attract and retain young talent by increasing the number of internships offered in our region. The RIC actively works with employers, assists them in developing internship programs and connects them to potential interns and regional colleges and universities. All services provided by the RIC are free to students and employers, which include but are not limited to the following:

For employers:

- Helping employers develop new internship positions or improve already existing internships;
- Providing employers with best practices for internships;
- Posting internship positions on the RIC website;
- Matching employers to students using our matching system;

For students:

- Providing a central point for finding internships;
- Matching students to employers;
- Forwarding student resumes to potential employers;

In a region where there is a potential pool of over 100,000 students, current efforts results in the placement of less than one percent in internships.

Internships are an opportunity for us to create a competitive advantage for the region by leveraging the number of students that we have. By connecting students with area employers and providing them with work experience, they will be more inclined to stay in the region after graduation. The RIC serves employers in the counties of Allegheny, Armstrong, Beaver, Butler, Clarion, Crawford, Fayette, Greene, Indiana, Lawrence, Mercer, Washington and Westmoreland, as well as the panhandle of West Virginia. Through the support of the thirty-three colleges and universities in this region, the RIC operates as a central point for students and organizations to connect. ## By-Law Changes Proposed For 2003

The By-Law Committee has met and reviewed the by-laws. The following changes are proposed and will be discussed and voted on at the March General Membership Meeting.

Article 1, Section 4, Add "The service area of the Waynesburg Area Chamber of Commerce will be the greater Waynesburg Area and the County of Greene. Businesses outside of this area who have a vested business interest in that area may also become a member."

Article 2, Section 1, Add item C. "Distinguished Service Award winners will automatically be given a lifetime, honorary membership in the Chamber of Commerce". Delete the words "and signed by the applicant" and "the prospective member will be presented to the Board of Directors for approval" Change the phrase "right to refuse any prospective member" to "right to terminate and membership"

Article 3, Section 6, Add as a last sentence "All absentee ballots must be signed and sealed and presented to the Executive Director prior to the vote"

Section 9. Change the phrase "Calls can be made in advance" to "Calls must be made in advance"

Article 4, Section 1, Add as a last sentence "The five out-going Board Members will not have a vote" Section 5 Remove "when requested" and replace with "and"

Article 5, Section 4, Add "The Executive Director is encouraged to continue professional development by membership in relevant associations and continuing education seminars and conferences. Such development will be supported by budgetary line items as necessary"

Article 8, Section 3. Change "December" to "February"

Article 9, Section 1. Move the first sentence to Article 8, Section 1. Add the words "and Mission Statement" after "by-laws" in that sentence.

## \$1,500 Chamber of Commerce Scholarship Applications Now Available

The Waynesburg Area Chamber of Commerce is now accepting applications from high school seniors for a \$1,500 scholarship they will award this May.

This is the thirteenth year the Chamber will award the \$1,500 scholarship. The scholarship program is open to any Greene County student who will be graduating from high school this spring.

The Chamber urges all high school seniors who have been accepted to a College or Technical School as an incoming freshman this Fall and have maintained a cumulative grade point average of 3.0 or better while in high school to apply for this scholarship.

Applicants will be required to write an essay on "What is your purpose in life and how do you plan to address this purpose through your education." Applicants must also furnish a listing of their school activities and local community involvement that will be used in the event of a tie. Applications are available at each County High School and the Greene County Vo-Tech or can be obtained by calling the Chamber of Commerce office at 724-627-5926.

Completed applications must be submitted by 4:00 pm on Thursday, April 24th. The winner will be announced May 14th and the Scholarship Award presented at the Chamber's monthly General Membership Meeting on May 28th.

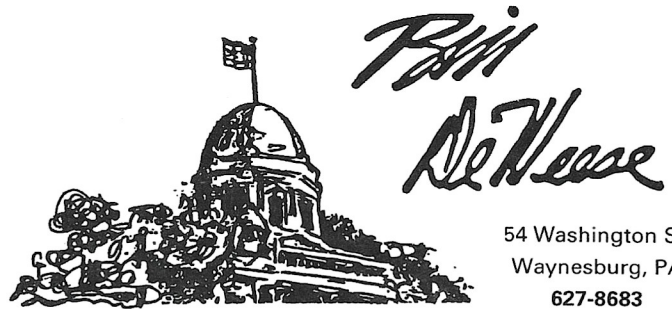
## United Way Holds Annual Awards Banquet

The Greene County United Way held its 23rd Annual Awards Dinner and Victory Celebration on February 27th at the Waynesburg Elk's Club. Over 120 people were present to honor the volunteers of the 2002 United Way Campaign. The local campaign amount raised is over \$252,769 so far, or 101% of the \$250,000 goal. RAG Cumberland and UMWA Local 2300 received the special "Lifetime Achievement Award". Since their first United Way campaign in 1980, Cumberland employees have contributed \$1,219,418. Award recognition was given to the employees of several area firms. The Gold Award, representing a 10% or more increase in employee giving, was awarded to: AMI, Inc. Baily Insurance/Coldwell Banker, Catholic Charities, Central Greene Community Area; Community Action SW, Cornerstone Care, First National Bank, Salvation Army and SCI-Greene. Organizations receiving the Silver Award for their leadership positions in the campaign and for their continuing support were: RAG Cumberland Resources and UMWA Local 2300; RAG Emerald and UMWA Local 2258; SCI-Waynesburg; Southeastern Greene School District; PA Department of Transportation; and PA State Police/Waynesburg Barracks. The guest speaker was Linda Moon, Program Coordinator for the Greene County Women's Center, a local United Way Agency. The United Way was represented by both staff and volunteers from Greene County. Shawna Wilkins, Greene County United Way Board Member and member of the nominating committee, made her report.
