Waynesburg College Mathematics Professors Co-Author Textbook

James R. Bush and Paul M. Sielski, associate professors of mathematics at Waynesburg College, have co-authored a statistics textbook designed especially for students in the College's Nursing Express Track (NET).

Entitled "Elementary Statistics for Health Care Professionals: A Workbook Approach," the text book will be released this summer. The 14-chapter workbook takes a modular approach and requires as little as five weeks to complete. Each chapter is accompanied by exercises with answers for practice.

Sielski noted that the material covered in the book prepares nursing students to be able to read research papers and experimental design reports. "The text is consumable and should be readable by the student," he said, adding that this is believed to be the first custom-designed text written for the NET Program.

"We designed the workbook with the quick pace of the AACE course in mind," Bush said. "We wanted students to work through a manual that they can keep and refer to in subsequent courses."

Sielski teaches at the main campus and also Summerfield Commons Center and is a resident of Waynesburg. He earned his doctorate in Mathematics Education from the University of Pittsburgh.

Bush has been teaching at Waynesburg for nine years. He lives in Pittsburgh and earned his doctorate in Biostatistics from the University of Pittsburgh.

On a motion by Katy Shultz seconded by Carol Howard, the minutes of the previous meeting were approved. On a motion by Andrew Corfont, seconded by Lena Hughes, the Treasurer's Report was approved. On a motion by Millie Wonderling, seconded by Mary Parkinson,

the Secretary's Report was approved.

COMMITTEE REPORTS: Ed DeVoge reported in the absence of Golf Outing Chair, John Glass, that The Golf Outing will be held on June 10 at the Carmichaels Golf Course who is a new member. The event will be a four-man scramble at a cost of \$60 per man, which includes lunch. Over 200 invitations were mailed and the committee is now seeking door prizes. Suzanne Huffman, chair of the Revitalization Committee, reported that the committee has joined the Main Street USA program and is currently beginning discussion on how best to organize the committee to be in the best possible position for funding. 'Downtown' has been defined by the committee to begin at 1-79 following the Route 21 corridor into downtown to the 21/18 intersection. The area will extend North and South for one block from the main route. She has been very pleased with the volunteer support on the government level through to the private sector. The committee is planning a town meeting to unveil the program for May 25th at the Waynesburg Theater and Groovy's with a 60's theme. Glenn Toothman and the new Executive Director of the Pennsylvania Downtown Center will speak at the event. Sheila Barger, chair of the Educational Fund, reported that 22 applications were received and have been sent to committee members for judging. The committee will meet on Monday to tally the scores and determine the winner. Melody Longstreth reported that applications have been released for the Miss Rain Day Pageant and the committee is currently finalizing the plans for the event. Bid requests for materials and services for the pageant have been placed in the newsletter. The Welcome to Waynesburg sign issue was updated for the members. We are currently in a re-permitting process with PennDot and the County will be taking down the sign and placing it in storage until the new location is ap-

OLD BUSINESS: No old business was brought before the membership.

NEW BUSINESS: BJ Quallich reported that Greene County Day at Kennywood Park will be held on July 10th. Ride all day tickets for \$13.50 along with bus tickets for \$21.00 are available at the Chamber office. WANB has donated 40 tickets to be used for the Miss Rain Day contestants. Millie Wonderling asked if the Chamber could write a letter to PennDot to encourage them to paint the Masontown Bridge, which is beginning to rust badly. Suzanne Huffman agreed for the office to look into plans for the bridge by contacting PennDot.

Suzanne Huffman reviewed the proposed changes to the By-Laws and Policies & Procedures and then opened discussion. Ed DeVoge pointed out that the Executive Committee should be changed from unanimous vote to three of the four in the event that someone might be unable to be reached for a vote. Also a quorum consisting of eight board members means that five members could control the vote on a given issue. A change to a higher number constituting a quorum would eliminate that issue. The membership discussed these changes and recommended that they be put back before the By-Law Committee for review and recommendation.

Waynesburg College Lamplighters To Go On Tour

Following a successful year of shedding musical light abroad in Greene County and the surrounding region, the Waynesburg College Lamplighters are heading to the nation's capitol to make a joyful noise unto the Lord.

On Sunday, May 7, the 19-member choir under the direction of Dr. Richard J. Stanislaw will present selections during two morning worship services to be held at the National Presbyterian Church in Washington, D.C. The invitation to sing came from Waynesburg College alumnus Dr. Harry Winsheimer, who is on the pastoral staff of the church.

During their stay in Washington, the group plans to visit the facilities of the American Studies Program, attend a concert at the National Cathedral, and do plenty of sightseeing. On the way home, they will perform for various music classes at Thomas Stone High School in Waldorf, Md.

Stanislaw said the students are excited about the trip, which is the culmination of an active year. Busy throughout the year performing concerts at area churches and community events, such as the annual Christmas concert, the Lamplighters also recently presented their annual spring concert at the Performing Arts Center on the College campus.

Stanislaw noted that participation in the Lamplighters is elective. "They put in lots of time and discipline," he said. "They're not music majors, but they sing as if they are . . . They do it for the love of it.

Still, all of this activity is nothing compared to what Stanislaw says he has in store for the group next year. In fact, he has already completed an itinerary for next year's tour, which will include Germany, Austria, and Hungary. In order to offset the costs for such an ambitious project, he is already busy booking concerts for next fall and winter.

Stanislaw, who is also Vice President for Academic Affairs at the College, began directing the choir two years ago. His love for God, and music, as well as his professional expertise, shine through every concert. A published author, his background also includes a master's degree in choral direction from Templeton University, where he studied under Robert Page, and doctorate in the same field from the University of Illinois.

While the Lamplighters sing a variety of music, they clearly prefer sacred selections such as "Gloria," "He Leadeth Me," and "Amazing Grace."

"The students sing in the Lamplighters as a ministry, as well as entertainment,"

Stanislaw said. "Churches are one of the few places where people still sing, because they have something to sing about."

Web Page

Build it right, and they will come - if you have or plan to have a Web site, first and foremost, make it easy to use. Web users of all types with varying skills and modem speeds all prefer sites that are logically organized and easy to navigate.

Slow speed kills - Surfing is an active process, and Internet users want their information downloaded quickly.

Be interactive and informative - Another important element is to maximize the potential of this hot two-way medium; allow users to communicate with you and in return provide information on what they are interested in. If they're interested in purchasing your product or services, give them the easiest and quickest options to complete that transaction.

Pay attention - Web users expect accurate and up-to-date information right away, so respond to questions and other requests in as close to real-time as possible. Update your site regularly with information and be responsive to consumers' needs. For example, a well thought out FAQ (Frequently Asked Questions) section can minimize the amount of questions your site receives by providing the answers in advance.

Keep things fresh - Update your site's content and technology as often as you can afford; if you don't, people will likely become bored and go elsewhere. You can be sure your competition is coming up with new and exciting ways to attract your customers to their sites.

Advertise it - Market your e-mail and Web address on and in everything your company does. Use both online and offline advertising vehicles to attract customers to your Web site, and play to your strengths in advertising. If you're a local store with an online presence, emphasize the fact that customers can avoid shipping costs or delays by purchasing the product locally, too.

Measure up - Keep a close eye on your Internet strategy and make sure it's meeting your objectives. Many monitoring tools exist to help you chart your progress. Look at the numbers, analyze what parts of your Web site are attracting the most users and build on that success. Routinely ask your customers how they heard about the site and what they liked best about doing business with you.


