JOHN OWEN, PRESIDENT, called the meeting to order at 12:15 and thanked everyone for attending. The president asked that everyone introduce themselves. The president requested that everyone look over the minutes of the September 23rd meeting. A motion was made by Gloria Richter to accept the minutes, it was seconded by Robyn Riggs and the motion was passed. The president stated that a Secretary's Report is not available at this time due to incomplete information in the Chamber office. He also stated that a Treasurer's Report would not be given at this meeting because the Chamber books are being audited at this time and he wanted to be sure that members received a correct report. A report on the financial status of the Chamber will be given at a later time.

COMMITTEE REPORTS: WAYNES-BURG CHAMBER ANNUAL DINNER: Suzanne Huffman reported that ninety-five people were in attendance for the dinner and she and John Owen felt that those who participated had enjoyed

the evening. Suzanne reported that the Chamber may clear \$565 from the dinner after expenses.

OLD BUSINESS: President Owen reported that the Chamber was represented in this year's walk for the Juvenile Diabetes Foundation by Kathleen Dukate, Toby Fancher, Frank Pecjak and Suzanne Huffman. Additional donations came from Richard Scott, Shirley Stockdale, Kathleen Gregg and Jackie Camp to make the Chamber's total contribution come to \$195.

John Owen, Suzanne Huffman, Jackie Kingora and Mary Parkinson represented the Waynesburg Chamber at the **Chamber After Hours** at Donna's Dollhouse in Carmichaels. President Owen urged members to visit the Dollhouse stating that is a unique enterprise. More Chamber After Hours will be planned in the spring, after holidays and winter are over.

NEW BUSINESS: President Owen acknowledged Andrew Corfont who explained that an effort was underway for the Chamber to show its support of the Waynesburg Central Raider Football Team who are undefeated this year and will be competing against Washington High School this Friday evening. Friday, October 30, will be proclaimed Raider Day. Posters have been ordered by the Chamber and donated by Rhodes & Hammers Printing and are available to be placed in area business windows. Business people are asked to wear red and black on Friday to show their support. The Observer has been notified of the Chamber's involvement in this project.

President Owen briefly explained the Chamber office situation to members. He reported that Jackie Camp quit her position and walked out of

the office on October 2. She has not communicated her position or reasons for leaving to any officers of the Chamber at this time. Carol Patterson will be filling in temporarily with Melissa Sampson as Secretary.

President Owen welcomed a new member to the Chamber: Turn of the Century Café, 30 North Washington St., Waynesburg, Lisa Rockwell, Owner/Operator.

Plans for the **Christmas Parade** on December 5 are underway. Four members have volunteered to be on the committee and more help is needed. President Owen urged members to call the Chamber office to volunteer.


