#### Local Leader Honored By College

Harry S. Anderson, Waynesburg, was the guest of honor as Waynesburg College dedicated the Harry S. Anderson Athletic Țraining Room in the Frank N. Wolf Field House.

The dedication ceremony took place at the J. F. Wiley Stadium. Anderson, a 1939 Waynesburg College graduate, was the local postmaster for more than 36 years, and an active community worker in fund raising campaigns for various causes. Harry was also chosen as the Chambers Distinguished Service Award winner in 1989.

"Harry has served the College for more than 60 years," said President Timothy R. Thyreen. "He was president of his class in his sophomore and senior years, athletic trainer under Coach Wiley, fund raiser, and active alumnus as a member of the Alumni Council and on numerous College committees. His life of service to the College and to the Waynesburg community is exemplary."

Waynesburg College recently observed the 61st anniversary of the first televised college football game when Waynesburg College traveled to Randall's Island in New York City to face Fordham University. Waynesburg College scored first, but Fordham won that game, 34-7.

#### R.A.G. AMERICAN **COAL MINE TOUR**




