

September 26, 2001

President Susan Stoy called the meeting to order at 12:10 pm. Members were asked to introduce themselves and place a business card in the bag for the door prize drawing. She welcomed new members, Greenwood Promotional Products, Rich's Homes and Beltone Hearing Center. She welcomed Amy Widdup as the new representative for the United Way. The door prizes were donated by Wendy's Old Fashioned Hamburgers and were won by Kathleen Gregg, Kathleen Dukate and Shelly Brown. On a motion by B.J. Quallich, seconded by Kathleen Dukate, the minutes of the previous meeting were approved. On a motion by John Owen, seconded by Nancy Davis, the Treasurer's Report was approved. On a motion by Millie Wonderling, seconded by Kathleen Dukate, the Secretary's Report was approved.

COMMITTEE REPORTS: Andrew Corfont presented the final Miss Rain Day Pageant financial report. He also reported that the committee still has to meet for a wrap-up meeting. The Rain Day Dunk Tank financial report was reviewed. The project made more money than was budgeted. Charles Perrine reported that the Revitalization Committee training would take place on September 27th at 6:00pm at Stover Center. Dinner will be served at a cost of \$6. Bill Fontana of the Pennsylvania Downtown Center will conduct the training for the four sub-committees and guide them into the process of making application to the national Main Street USA program which will ultimately be the path to grant money for the project. On October 10th, the Revitalization committee will hold a grand celebration of the Mission Statement. He stressed the need for a good turnout at this celebration. The event will be held at the Waynesburg Theater

and will begin with a reception at 5:30pm followed by a presentation of the Vision Statement. The evening will also feature historical displays and video as well as special music. B.J. Quallich of the Promotion sub-committee of the Revitalization project reported that they are underway with a fourth quarter promotion featuring a giveaway of a color TV. A 4-page tab will come out in the Observer-Reporter and radio advertising will direct residents to downtown merchants to register. A December promotion is being planned and will include an 8-page tab due to the great response received on the first attempt. She stressed that all area business are welcome to participate and not just those located in downtown.

OLD BUSINESS: Susan Stoy announced that the 5th and final edition of the Christmas Bulbs will be arriving soon and a special set price of 5 for the price of 4 will be marketed. The series began with the current courthouse during its renovation and will end with the original log courthouse during its renovation. We have already visited the Arts in the Park Festival at Ryerson Station and passed out many order forms for the special sets. We have three more public events on the calendar with them.

NEW BUSINESS: The date for the annual member banquet was set for November 10th at the Waynesburg Elks. The committee is adding new things to the banquet to increase attendance and all members are encouraged to participate. The event will be focused on members and their achievements. The Distinguished Service Award will also be presented at the banquet. Nancy Davis announced that the Rotary Multiphasic Blood Screening would be held on October 13 and 27 at the Greene County Memorial Hospital. Susan Stoy announced that the Greene County Senior Fair would be held on October 12th at the Fairgrounds. The event is co-sponsored by Rep. Bill DeWeese, Rolling Meadows, Area Agency on Aging and the County Commissioners. Space is still available for exhibitors. Farley Toothman announced that PennDot has formally committed to enhance the Morrisville Bottleneck which means that it will not only work well, it will also look nice. These traffic problems affect Chamber members and we will now have an opportunity to plan how our town should look, work and feel. He also announced that limited edition prints of the log courthouse done by local artist, Tom McConville, are available for sale at Rhodes & Hammers. They are looking for a group to purchase the entire collection and sell as a fundraiser.

Dr. Nancy Davis, of the Greene County Education Center presented Module I of "Human Capital and the Changing Economy" from the University of Pittsburgh Institute of Politics Human Capital Policy Initiative. Complete copies of the slides are made a permanent attachment to these minutes.

On a motion by Andrew Corfont, seconded by Linda Corfont, the meeting was adjourned.

ROTARY BLOOD SCREENING

The Waynesburg Rotary Club will be sponsoring their annual Multiphasic Blood Screening Program on Saturday, October 27th. Greene County Memorial Hospital will cooperate on the program. This is an “early warning” health test using a sample of blood to find current or potential health problems. This is not a blood donation program. Testing will begin at 7 a.m. All participants must fast 12-14 hours and can only participate if they have signed up beforehand. Call 724-627-2703, 724-627-2695, 724-627-2602 or 724-627-2492 to register from 9 am to 3 pm any weekday. Please be prepared to give your name, address, and date of birth as well as the name and address of your private physician to whom your results will be sent. The 25 - test profile of the blood sample will include:

The American Stroke Association will offer free stroke assessments. This takes approximately 15 minutes. The samples will be taken at Greene County Memorial Hospital. The \$25 fee will be collected on the day of testing and covers the entire process, including collection of blood samples, analyses, and a confidential report to your physician on the results. Also available will be Urinalysis at \$5 and Occult Blood Test Kits for early detection of colon/rectal cancer at \$5. A Prostate Specific Antigen test will also be available for the early detection of prostate cancer for an additional fee of \$10.

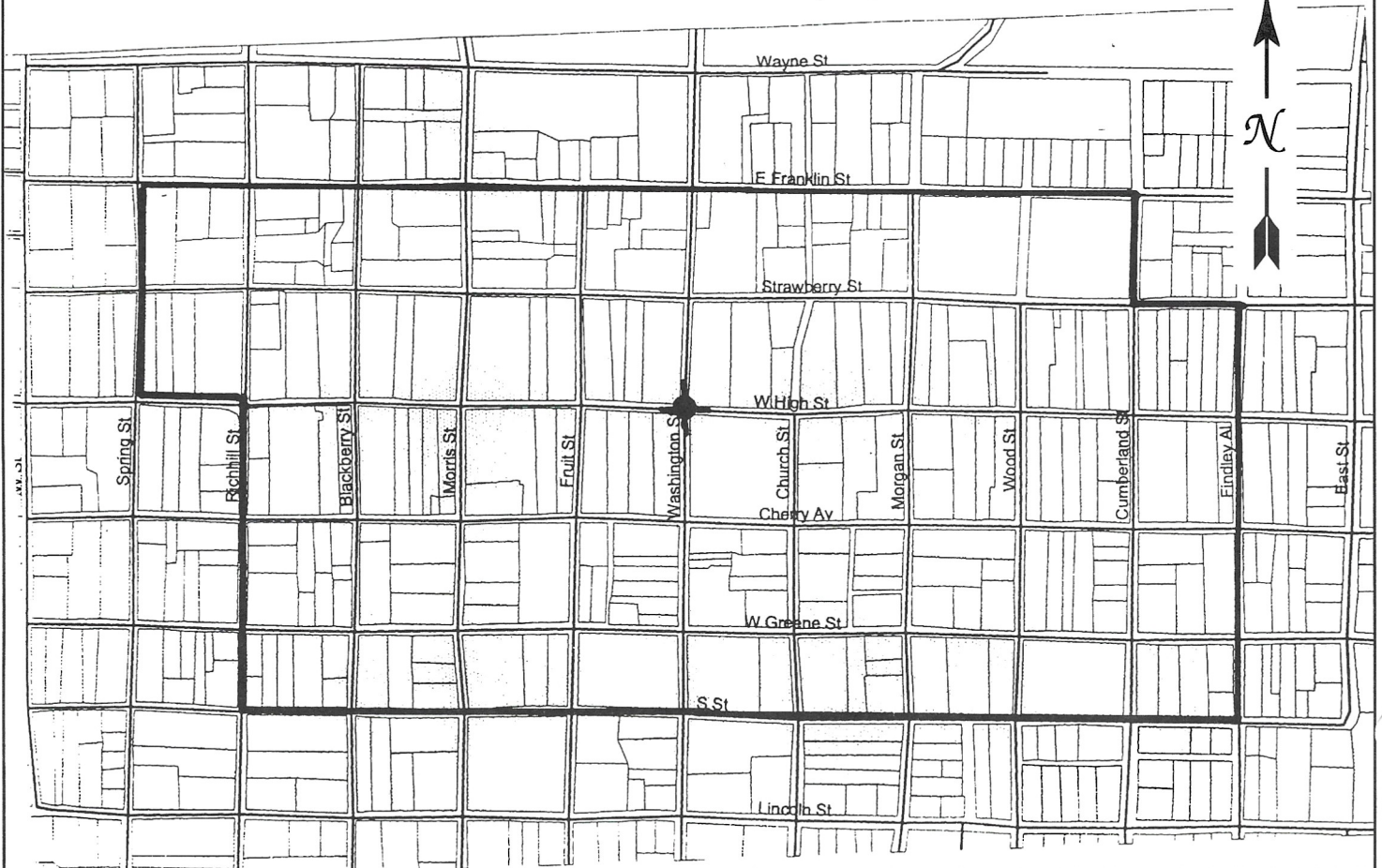

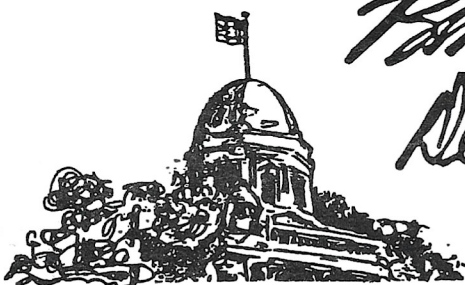

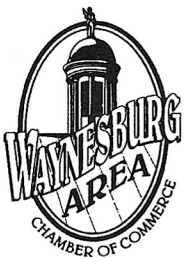
