Fox Auto Sales

In 1941 when brothers Ollie and Willis Fox opened their Ford and Mercúry dealership in Waynesburg, Franklin D. Roosevelt had just begun his third term, war clouds were hovering over Europe and automatic transmissions and car air conditioning were unheard of. A lot has changed since then, not only in the way cars are built but also how they are sold and serviced. One thing that has not changed though is the Fox family's commitment to customer satisfaction. Today the third generation of Foxes employs a staff of over 20 full time employees at the 743 E. High Street location.

Bob Fox, along with sons Ron, Mark and David, oversee the entire dealership which has enjoyed a substantial increase in sales volume in 1994. August of 1994 was the best new car and truck sales month ever for Fox and projections point to record setting sales numbers for the entire year. Dealership President Bob Fox attributes the dramatic growth in new vehicle sales in large part to the high quality products being supplied by Ford Motor Company. In addition to having America's best selling truck, the Ford F-Series, and the nation's top selling car, the Ford Taurus, 5 of the top 10 best sellers are Ford products.

Another important reason for their success according to Fox is a strong commitment to training for all employees. Virtually all of the sales, service and parts personnel receive updated training from Ford Motor Company at seminars conducted through the Eastern United States.

The people at Fox are also deeply committed to community service as well. Bob is currently President of the Waynesburg Volunteer Fire Company and all of his four sons are officers. Several other employees of the dealership are also active in community service organizations such as the Fire Company, Rotary and Lions Clubs, Cub Scouts, and the Greater Waynesburg Area Chamber of Commerce.

The ownership is not one to rest on their laurels however; despite record setting business, plans are well underway to build an entirely new state of the art showroom and service facility starting in 1995, making Fox Auto Sales not only Waynesburg's oldest dealership but the area's most modern as well.

CCSC Announce New Dental Plans for Chamber Members

The new **DentalPlus** plan uses a select network of Blue Shield dentists to provide 100% coverage for exams, diagnostic and preventative services as well as discounts on other related services.

These prices do not include a 3% administration charge and \$10 billing fee.
