Waynesburg Prosperous and Beautiful, Inc. recently installed flower baskets on each lamppost in the downtown area. Each day they become more and more lovely.



MEMBERS RECOGNIZED

Lavern's Restaurant has recently taken the spotlight as the setting for the NBC drama "The West Wing." UNCLAIMED PROPERTY LAW CHANGES

Recent changes to Pennsylvania's Unclaimed Property Act took effect on June 29th, 2002. These changes will impact your unclaimed property report for calendar year 2002. The most significant change to the law reduces the "dormancy period" for reporting most categories of unclaimed property from seven to five years. In addition, un-cashed payroll checks must now be reported after 3 years, rather than seven. The change in dormancy means that property due for years 1995, 1996 and 1997 (and in the case of payroll checks, 1998 and 1999) is due next April 15. This change affects Financial Institutions, Business Associations, Insurance Companies, Utilities, Hospitals, Government Agencies, Political Subdivisions, Public Officers, Authorities, Legal or Commercial Entities and Fraternal Benefit Societies, not limited to Nonprofit Organizations. The threshold amount for aggregate reporting is now increased from \$25 to \$50. All amounts less than \$50 can be reported in the aggregate without names and addresses. Also under the new legislation all business entities must report and remit all property by April 15. In the past, the law allowed businesses to report property with a value greater than \$100 but not remit until a demand letter was received from our office. The new law also grants an amnesty period through December of 2003. The amnesty grants a waiver of interest and penalty during this period. If you are holding property that should have been reported in prior years, this is a great opportunity to become current without being penalized. The sections of the law affecting gift certificates, traveler's checks, court-ordered utility refunds and property distributable in the course of dissolution remain the same. Regional Emergency Traning Center Ground Breaking

Westmoreland County Community College recently broke ground for the Regional Emergency Training Center in South Huntingdon Township. The \$7.5 million state-of-the-art facility will be used to train fire fighters, police and emergency service personnel from southwestern Pennsylvania, Ohio and West Virginia. The Center will be located on a 160-acre site, off Interstate 70, donated by Westmoreland County. The county is also paying for half the construction costs of the first phase of the project, with the state funding the remainder. The initial phase of the project will include construction of a six-story firefighter training structure, commonly referred to as a "burnbuilding," along with a classroom and administrative office facility. The 13,300square foot burn building is being designed to simulate residential, commercial and industrial structures. The burn tower will have flat roofs and peaks, open staircases, enclosed staircases to resemble homes, retail stores, hotels and warehouses. The facility has options not only for fire fighter training, but police tactical units as well. The groups can practice fighting fires or rescue operations in a six-story high rise, three-story residential setting or both. Two computerized natural gas furnaces, operated by a trainer, will create live fire situations in the burn building. The fire simulators will be equipped with sensors that will gauge whether the fire is being extinguished properly. If the firefighters don't extinguish it properly, the

controller will be able to make it worse. A natural pond on the site will provide some of the water for extinguishing the fires and could also be used for water rescue training. The classroom building, which will resemble a fire station, will be adjacent to the burn building so student will be able to come right in off the burn pad, in full gear, take off their fire equipment in the classroom and watch films of their performance. The college plans to expand the project to encompass a tactical village which will include a railroad hazardous materials training area, a driver training pad for fire trucks, police cars, school buses and ambulances, and indoor and outdoor firing ranges. The tactical village could also be used for antiterrorist training. The total cost of the entire project is approximately \$30 million. The college is seeking funds from other sources to pay for the remainder of the project. Completion of the first phase is anticipated for August 2003.

Southwestern Pennsylvania Women's Business Plan Competition

Jeanine Henry, Management Consultant for the University of Pittsburgh Small Business Development Center Greene County Outreach Office is pleased to announce that four local entrepreneurs have successfully submitted entries to the WriteIdea, a unique business plan competition for women-owned enterprises that are start-ups or have been in business for a year or less within the county. The four individuals are Ms. Kathy J. Kiger, owner and operator of the Airport Restaurant, Dr. Anita L. McMillen, VMD, president of Braden Run Animal Hospital, Ms. Deborah Rohanna, and Ms. Leigh A. Scritchfield, president of S&S Fire Protection, Inc. A fifth client of the SBDC, Ms. Sarah L. Gancos, owner and operator of Memory Lane Photography is participating in the Fayette County portion of the competition.

A panel of judges representing Fayette, Greene, Washington and Westmoreland Counties are currently reviewing each entry for innovation, employment capability, a management plan, high growth potential and overall viability. Once the initial scoring is completed, two of the four Greene County entrepreneurs will be chosen as finalists and will travel to Seton Hill College's National Education Center for Women in Business in Greensburg, PA to make a presentation in support of their plan and interview with the judges panel on Wednesday, September 18th. One winner from each of the four designated counties will split a cash prize of \$25,000. Seton Hill University's National Education Center for Women in Business will announce the winners on Thursday, September 26, 2002, during a free networking event at the Christian W. Klay Winery located in Chalk Hill. The local participants and eventual winner will also be recognized at the Waynesburg Area Chamber of Commerce Annual Member Banquet during the Special Community Awards portion of the program scheduled for Saturday, October 12th, 2002.

In an effort to accelerate the business start-up process of women entrepreneurs in the Southwest Region of Pennsylvania, Seton Hill College's National Education Center for Women in Business, is administering the business plan competition on behalf of the Pennsylvania Department of Community and Economic Development (DCED) and the Appalachian Regional Commission (ARC) who are supporting this initiative.

The competition was open to start-up businesses or businesses in operation for less than a year that are at least 51% owned by a woman with a maximum sales volume of \$100,000. For consideration, applicants must be 18 years of age and within Fayette, Greene, Washington and Westmoreland Counties.


