#### PA Chamber Uurges Congress to Extend Small Business Tax Cuts

To mark National Small Business Week, the Pennsylvania Chamber of Business and Industry and Americans for Prosperity Pennsylvania have launched a campaign urging Congress to make the small business provisions of the 2017 Tax Cuts and Jobs Act permanent.

Without action the cuts are set to expire at the end of this year.

The act reduced the federal corporate tax rate from 35% to 21% and included several provisions that benefit small businesses including a 20% deduction for qualified business income (QBI) for pass-through businesses, known as Section 199A.

According to the chamber, this deduction has allowed millions of small business owners to reduce their tax liability and reinvest in their operations, employees and communities.

It noted that the law also expanded research and development tax credits and improved asset depreciation and business expensing.

Those measures set to sunset at the end of this year unless Congress votes to extend them. AFP Pennsylvania State Director Emily Greene said they are counting on Congress to act.

"If our delegation doesn't act, taxpayers will face an average increase of more than \$2,300 per year. After four years of record-high inflation, we simply cannot afford to pay more."

Failing to renew these tax provisions would deal a serious blow to Pennsylvania's economic competitiveness, said PA Chamber President & CEO Luke Bernstein.

"Small businesses across the Commonwealth are already navigating workforce shortages and dramatically higher costs compared to 2017," Bernstein said. "The last thing they need now is a higher tax burden that makes it harder to hire, invest and grow. We have an opportunity — and a responsibility — to come together and give small business owners the certainty they need to succeed."

As part of their campaign, the PA Chamber and AFP will release a series of videos highlighting the voices of business leaders, taxpayers and policymakers who support extending these policies.

This state effort is a part of AFP's \$20 million nationwide campaign in support of the TCJA.

It's the single largest investment of any outside, limited-government conservative organization toward protecting the pro-business tax provisions.

Penn State Extension educators and other faculty serve as instructors and are certified by the National Restaurant Association. All have received training on the most current research on food safety.

Even if your organization has been doing this for years, things change and it is important that volunteers are up to date and knowledgeable about rules and regulations governing food safety. Don't risk your customer's health or your organization's reputation.

Cooking for Crowds: A Volunteer's Guide to Safe Food Handling was developed in collaboration with the Pennsylvania Department of Agriculture.

## Waynesburg University Celebrates Class of 2025 at Commencement Ceremony

Waynesburg University held its Commencement Exercises Sunday, May 4, on the Lawn of Miller Hall, honoring nearly 300 undergraduate, graduate and doctoral students.

Toby Z. Rice, President and Chief Executive Officer of EQT Corporation, addressed the Class of 2025 as the Commencement speaker, and Jeffrey E. Arnold, Executive Director of the Association of Presbyterian Colleges & Universities (APCU), served as the Baccalaureate speaker.

During the Commencement Address, "You Don't Have to Know, You Just Have to Begin," Rice reflected on his own unconventional journey, from chimney sweeping and oil rigs to co-founding Rice Energy and leading a major energy company.

Rice emphasized that traditional advice like hard work, innovation, risk-taking, and luck weren't responsible for his success. Instead, he highlighted the power of perseverance, encapsulated in the word "almost."

"When you're doing bold things, it's going to be difficult, and you are going to come to a place where you almost lose faith, you almost give up, but it's important to keep moving forward," Rice said.

Rice and Arnold were awarded honorary Doctor of Humane Letters degrees during the Commencement ceremony. Hailey Marks, an English (professional writing) major from Canonsburg, was named the valedictorian and delivered the valedictory to the University. Seth Robertson also gave remarks as the graduate program representative.

In addition, Ross Owens, a children and youth ministries major from Sewickley, was awarded the 2025 Douglas G. and Kathryn D. Lee Servant Leadership Award. This award was established by the Waynesburg University Board of Trustees to honor the leadership and commitment of Douglas and Kathryn Lee to the University. It is awarded each year to one graduating student who has demonstrated exceptional leadership qualities over the course of their time at Waynesburg University in the mission focus areas of faith, learning and serving.

During the Baccalaureate ceremony, the focus of Mr. Arnold's message, "Blessed are the graduates, For They Shall..." was Matthew 5:3-12.

Mr. Arnold urged each graduate to view their career and character not as separate pursuits, but as intimately connected facets of their divine calling.

"In practical terms," he said, "this means continually asking yourself: How can my work be an expression of love, service, and integrity? How can I let my inner virtues shape the way I engage the world? And, finally, how might my journey evolve if I were to view each job and every task as an opportunity to serve a higher calling...rather than merely a stepping-stone to greater success?




## The Special Events Commission of Waynesburg Borough is proud to announce the establishment of a new award in honor of the late Timothy M. Hawfield.

Chief Hawfield: First Responder Service with Honor Award Timothy "Chief" Hawfield was more than just a name in Waynesburg—he was a cornerstone of the community whose influence continues to resonate today. Through his distinguished career as a police officer and his unwavering commitment to community service and volunteerism, he touched the lives of countless individuals.

Tim's journey in law enforcement began in June 1979 when he joined the Waynesburg Borough Police Department. By May 1981, he had earned the title of chief of police, a position he held with pride and dedication for 32 years. During

his tenure, Tim's contributions didn't go unnoticed; he earned numerous awards and citations, and one of his proudest achievements was his pivotal role in promoting the "Officer Phil" child safety program in local elementary schools.



He also made his mark as a Little League baseball coach and as an "American Policing" instructor at Waynesburg College. A Civil War enthusiast, Tim was always ready to share his passion and knowledge with anyone eager to listen. He even founded the beloved "Husband Calling Contest" at the annual Rain Day Festival, which he found highly entertaining. In 2013, Tim received the Waynesburg Chamber of Commerce Distinguished Service Award, a fitting tribute to his lifetime of dedication. A 2020 recipient of the Jack McCracken Award, Tim was also deeply involved in numerous organizations He was an active member of the Fraternal Order of Police, Salvation Army, and First Baptist Church of Waynesburg. His community work extended to roles with the Western PA Chiefs of Police Association, the PA Safe Kids Coalition, the Greene County Drug Task Force, and many other local initiatives focused on youth, wellness, and safety.

Above all, Tim was a devoted husband, father, and grandfather, whose love for his family knew no bounds. He was a loyal brother, a cherished friend, and a mentor to many. His legacy lives on through the countless lives he touched and the community he helped shape.

\*Documentation must be provided of Employment/Volunteer Status within Greene County The First Responder who is selected must have demonstrated consistent excellence in their performance of duties, constant dedication to their official responsibilities, continuous growth in responsibilities/skills within their profession, and community involvement aside from being a Greene County First Responder. The Hawfield Family and Special Events Commission will review all nominations thoroughly and conclude with one award winner. This will be an award that the Special Events Commission will continue to do each year, with the permission of the family. This individual will be awarded on July 29, 2025, at 6:00 P.M. at the Rain Day Festival.



## Waynesburg University Hosts Showcase of Growth on Campus, Highlights New and Enhanced Facilities



Waynesburg University hosted a Showcase of Growth event Friday, April 11, for local media, law enforcement and government agencies to tour the new and recently renovated facilities on campus.

The schedule of events began with light refreshments and welcoming remarks from Dr. Dana Cook Baer, director of the Center for Criminal Justice and Forensic Investigation and professor of criminal justice, Waynesburg University President Douglas G. Lee and Rev. Dr. Parker T. Williamson, chief operating officer of The Stover Foundation. Shortly thereafter, a ribbon cutting was held for the new Center for Criminal Justice and Forensic Investigation. The event concluded with tours of four facilities both on and off campus.

Tours began at the Center for Criminal Justice and Forensic Investigation, which features state-of-the-art, high-tech simulators on the lower level, including a MILO Range Theater 180 and Pro system training for interactive Use-of-Force and Crisis Management Training, and an L3 Harris driving simulator. On the upper level is a spacious area with cutting-edge technology that can be converted into three separate classrooms, a conference room and office space, accommodating functions of up to 120 people.

Next door, participants toured the newly renovated Practical Exercise Facility, formerly known as the CSI House. This building now features a mock courtroom, which has been named "The Williamson Courtroom" in honor of the contributions of Rev. Dr. Williamson; a bloodstain pattern interpretation room; and a fingerprint lab.

These facilities provide cutting-edge training, preparing students to excel in the field. The enhanced Center will also enrich training opportunities for local and regional first responders, strengthening the University's long-standing relationships with law enforcement agencies such as the FBI, CIA, ATF, police departments and probation offices.

Tours continued to the bottom floor of Eberly Library, where the newly renovated Pathways Center is located. The Pathways Center offers comprehensive support services to students on campus and includes a new community learning space, private testing and interview rooms, a restructured Career Closet storefront with changing rooms, a sensory room and staff offices. After a brief stop in the eHIVE, shuttles departed for a tour of Alston Farm, a well-preserved historic house, log cabin, barn, renovated classroom and greenhouse space on 52 acres, recently donated to the University. Alston Farm provides incredible opportunities for new and expanded student instruction and community outreach. Waynesburg University has hired a consultant to develop a strategic plan for the farm, made possible through a grant from the Appalachian Regional Commission (ARC). The plan is expected to be complete in fall of 2025.

Waynesburg University has seen tremendous growth in recent years, from new and enhanced facilities to property expansion, all made possible by the incredible generosity of the University's donors and other supporters.

In 2022, the lobby outside of the auxiliary gym was renovated into a new Recruitment Lounge, where coaches and prospective-students can meet. That same year, locker rooms received significant updates in the Rudy Marisa Fieldhouse and John F. Wiley Stadium, and a new video board and scoreboard were installed in Rudy Marisa Fieldhouse to enhance the game day experience. A new, state-of-the-art Esports Arena was constructed in the Buhl Humanities Building. One of the largest in the region, all 25 stations are equipped with the following: Alienware Aurora R12; Alienware 38" Curved Gaming Monitor; Alienware Gaming Mouse; Alienware Mechanical Gaming Keyboard; Bose QuietComfort Noise Cancelling Headphones; and an electric height adjustable standing desk. The space also includes an Optoma projector and a separate viewing room with a SmartGlass window. Completed in August 2023, John F. Wiley Stadium received several additional enhancements, which included a 250-foot-long retaining wall with a 25-foot-high net and lights; banners on retaining wall honoring senior football and soccer student-athletes; signage surrounding the field and underneath the bleachers; President's Box renovations; home locker room showers; covered benches for football and soccer teams; an athletic training room; parking lot expansion; and pavilion.

The University's award-winning Entrepreneurial Leadership Program unveiled its new innovation hub in February 2024. The Entrepreneurial Hub for Innovative Ventures and Endeavors (eHIVE), located on the first floor of Stover Campus Center, houses equipment that supports student entrepreneurs in their prototyping efforts and enables them to make products to sell for their own small businesses.

One additional property, The Thyreen Retreat Center, was kindly donated in accordance with the wishes of the late Chancellor Thyreen and his family. The farm will serve as a retreat center.





## Certified Recovery/ Certified Family Recovery Specialist Training

The Certified Recovery/Certified Family Recovery Specialist Training consists of 78 hours of education:
66 in-class hours, and 12 hours of homework.
Participants must meet all of the Pennsylvania Certification Board (PCB) requirements:

#### The Role of the Recovery Specialist

The Recovery Specialist is an individual with personal, lived experience of their own recovery. By offering insight into the recovery process, Recovery Specialists are able to share a unique perspective with those with similar life experiences. Recovery Specialists accept and agree that their experience as a person in recovery from a substance use disorder will be known by their colleagues, individuals served, and others with whom they may share that they have achieved this credential. The Recovery Specialist is a role model, mentor, advocate, and motivator. Recovery Specialists advocate for the individual, the recovery system, and recovery-oriented services, and they assist to identify and reduce stigma. Recovery Specialists advocate to eliminate barriers, increase natural supports, and build community. Services provided by the Recovery Specialist substantially improve an individual's and a family's ability to sustain recovery and wellness.

#### **Certified Recovery Specialist (CRS)**

A credential for individuals with personal, lived experience in their own substance use disorder recovery. By offering insight into the recovery process based on their own experience, recovery specialists are able to offer a unique perspective while providing recovery support services. The CRS is not a sponsor, case manager, or therapist, but rather a role model, mentor, advocate, and motivator.

Certified Family Recovery Specialist (CFRS) A credential for adults who have been directly impacted by their own family member's or loved one's substance use disorder. The CFRS shares their lived experience with other families to provide recovery support services and understands the stigma associated with substance use disorder and its impact on the family. CFRSs are trained to help families move into and through the recovery process.

- 18 months of current sustained personal lived recovery
- 1000-word statement describing personal lived experience with addiction, recovery, and history of sustained recovery
- Application to the PCB, payment of fee, and successful completion of the CRS exam
- Sign an ethical code of conduct

#### **Certified Family Recovery Specialist**

- · High school diploma
- Successful completion of the 78 hour CRS/CFRS Training Program
- History of lived experience of being directly impacted by family member's or loved one's substance use disorder
- 1000-word statement describing lived experience of being impacted by a family member's or loved one's substance use disorder and navigating of systems, accessing of resources, and what family recovery means personally
- Three letters of reference/character as described by the PCB
- Application to the PCB and payment of fee
- Sign an ethical code of conduct

#### **Technology Requirements**

- Be comfortable with computers, computer applications, and other technology
- Ability to complete online homework (12 hours)
- Laptop or desktop device (Mobile devices such as tablets and smartphones cannot be used)


