Market Operations and Vendor Requirements

The Carmichaels Farmers' Market provides an opportunity for area residents to purchase fresh, locally grown fruits, vegetables, flowers, and herbs directly from the farmers who grow them. The market also features baked goods, prepared foods, eggs, and wine.

The community is invited to the Farmers' Market to support local farmers and socialize with friends and neighbors. The Carmichaels First Thursday Farmer's Market is presented by Greene County Chamber of Commerce.

Market Operations

The Market will operate on the First Thursday of June, July, August, September and October of 2026. It will operate from 4:00pm to 7:00pm. Set up time is 3:00 PM. An on-site Market Manager will supervise the weekly activities of the market, enforce Market rules, collect weekly fees, and assist vendors and shoppers.

Vendor Requirements

Vendors are responsible for having the appropriate local, state, and federal certifications and/or licenses to conduct business. Copies of this paperwork must be presented or emailed to the Chamber to be kept on file.

Vendors are required to provide their own tables, chairs, and tents.

1. Farm Produce Vendors:

- a. Produce and Food Products sold by the vendors must be grown and/or produced in Greene County and other Pennsylvania Counties.
- b. The vendor will identify Greene County Produce with the provided signage.

2. Non-Produce Vendors:

- a. Vendors' sales may include:
 - Baked goods, Meat, Eggs, Dairy Products, and other Prepared Foods
 - Live Plant, Cut Flowers, and Dried Flowers
 - Bath and Body Products, Beverages, and Food Stuffs
 - Crafts (Approved by Market Manager)
 - The Market reserves the right to prohibit the sale of any item.
- b. Products sold by the vendors are to be made or sourced in Greene County, Pennsylvania, and/or other Pennsylvania Counties.
- c. The vendor will identify Greene County Products with the provided signage.
